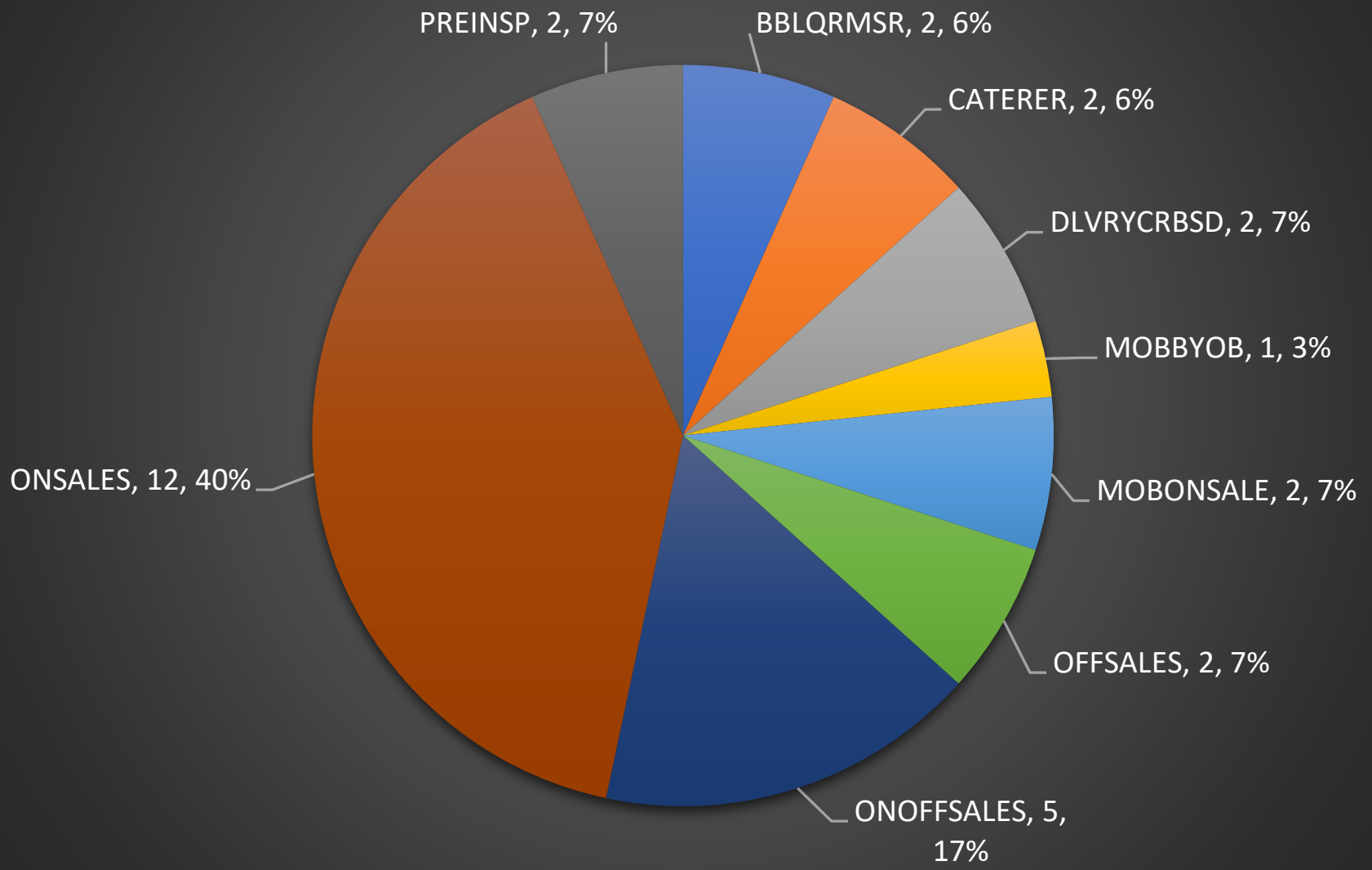

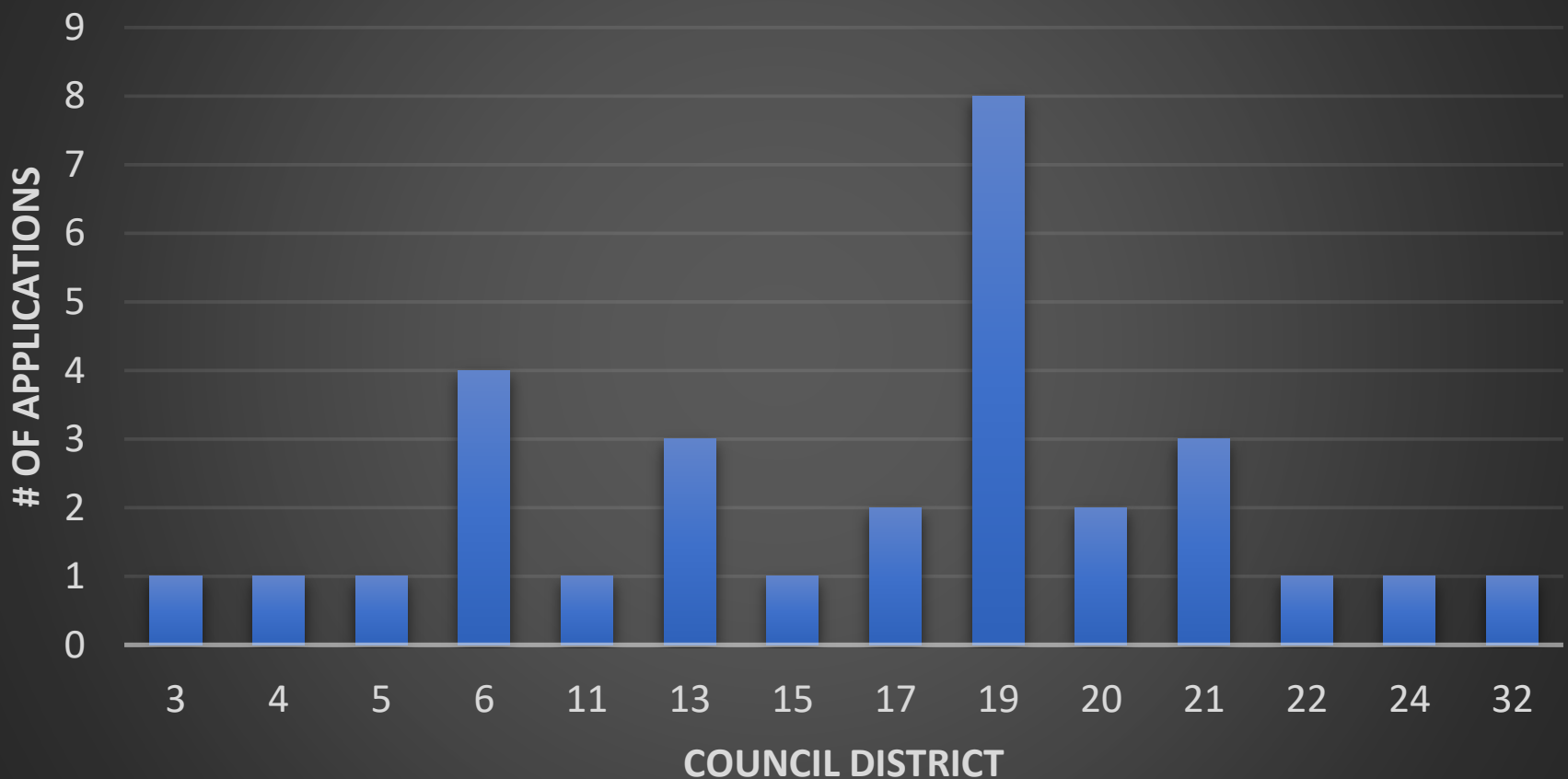

## Apps by Council District

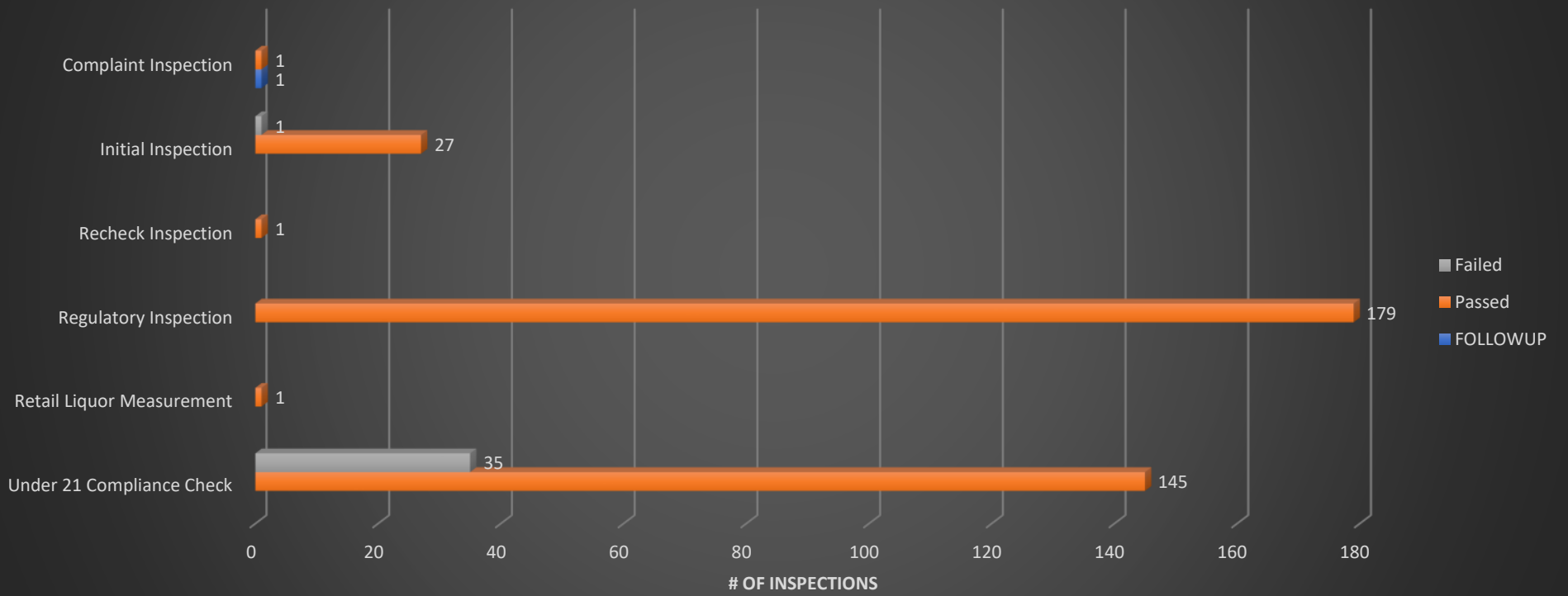




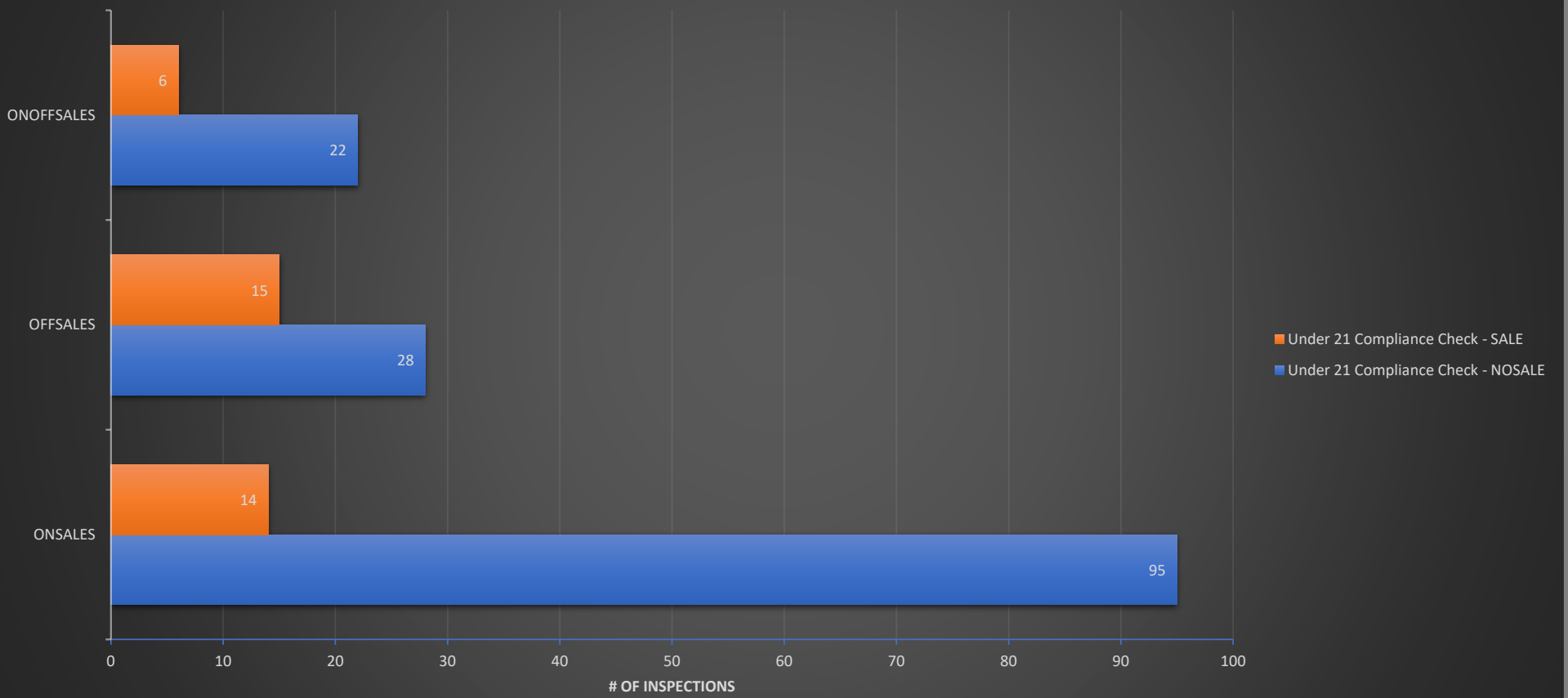

## Under 21 Compliance Check Results by Permit Type



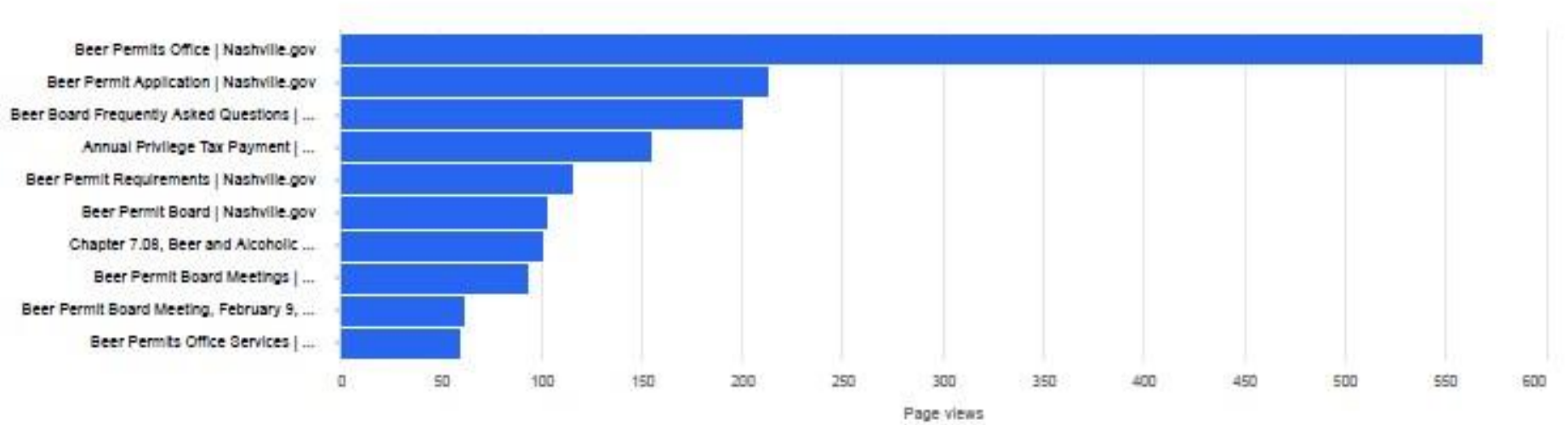
