**CASE MANAGEMENT ANALYSIS
2024 THROUGH 1st QUARTER**

Criminal Court Summary, 2024 compared to 2023, through Q1:

1. The average number of days from filing in Criminal Court to disposition was 328.4 days, a decline of 56.1 days below the same period in 2023. The number of defendants disposed decreased 12.7%.
2. The average time from filing in Criminal Court to disposition for indicted defendants was 406.5 days, a decline of 35.6 days. Disposed indicted defendants declined 22.7% through Q1 2024. Defendants filed in Criminal Court on Presentments/Indictments increased 1.1%.
3. The average case age for defendants disposed by Information Agreements slightly decreased 0.1 day to a total of 53.9 days. The number of defendants disposed by Information Agreements increased 32.5%. Defendants filed in Criminal Court on an Information during this time increased 18.3%.
4. Direct Presentments averaged 459.9 days from filing to disposition, a decrease of 13.0 days (-2.8%).
5. Defendants disposed in Criminal Court without a trial took 312.7 days to dispose, a decline of 61.4 days. The case age for trial defendants was 1,205.8 days, an increase of 289.2 days above 2023.
6. Jailed defendants disposed in Criminal Court took 253.9 days to process from filing to disposition, 18.9 days shorter than 2023. The average time from filing to disposition for bond defendants was 391.0 days, a decrease of 60.0 days.
7. The number of defendants served a capias in Criminal Court declined 38.5%. The impact of these capiases on the average case processing time was 19.7 days, which was 9.7 days shorter than during the same period in 2023.
8. Defendants with a probation violation in Criminal Court averaged 67.2 days from PV arrest to PV disposition. This was 16.3 days longer compared to the previous year.

General Sessions Court Summary, 2024 compared to 2023, through Q1:

1. The average time from arrest to disposition in General Sessions Court was 107.7 days, a decline of 23.2 days. There were 3.3% more defendants disposed in 2024 compared to 2023. The number of defendants filed in General Sessions Court during this period decreased 1.0%.
2. The average time for defendants who were to bound over to Criminal Court was 74.5 days, a decline of 17.0 days. The number of defendants that were bound over to Criminal Court increased 21.3%.
3. For defendants whose warrants were concluded without a trial (pled or dismissed), the average time from arrest to disposition was 119.6 days, a decline of 22.1 days.
4. The average time to dispose jailed defendants was 16.3 days, a decline of 0.2 days. Defendants on bond averaged 162.2 days. That represented a decrease of 30.7 days below 2023 levels.
5. The number of General Sessions defendants served a capias increased 1.1% in 2024 through Q1. The impact the capiases had on the average case age was 15.5 days, which was 0.2 days shorter compared to the same period in 2023.

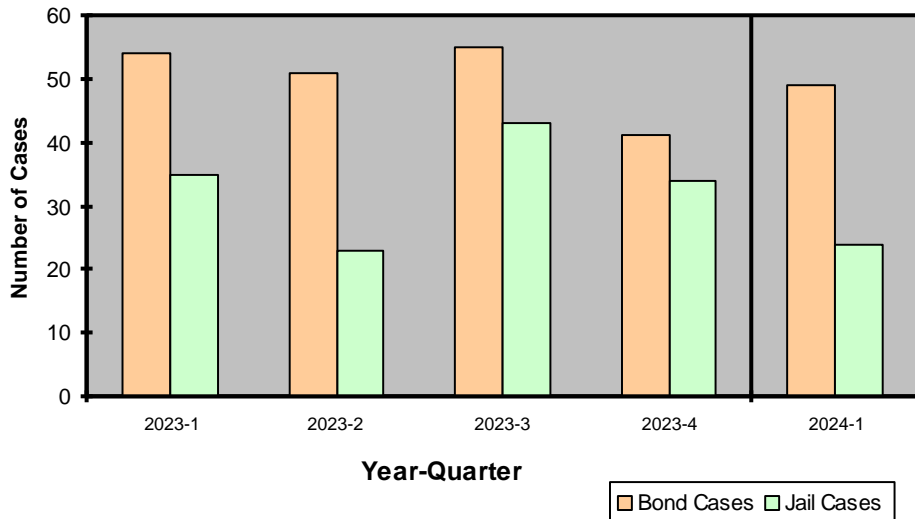

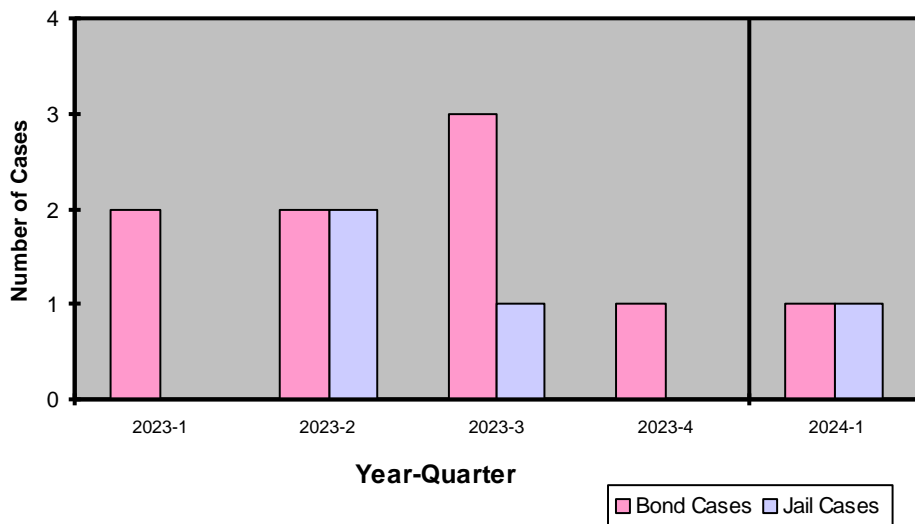
Disposed Without a Trial Number of Cases



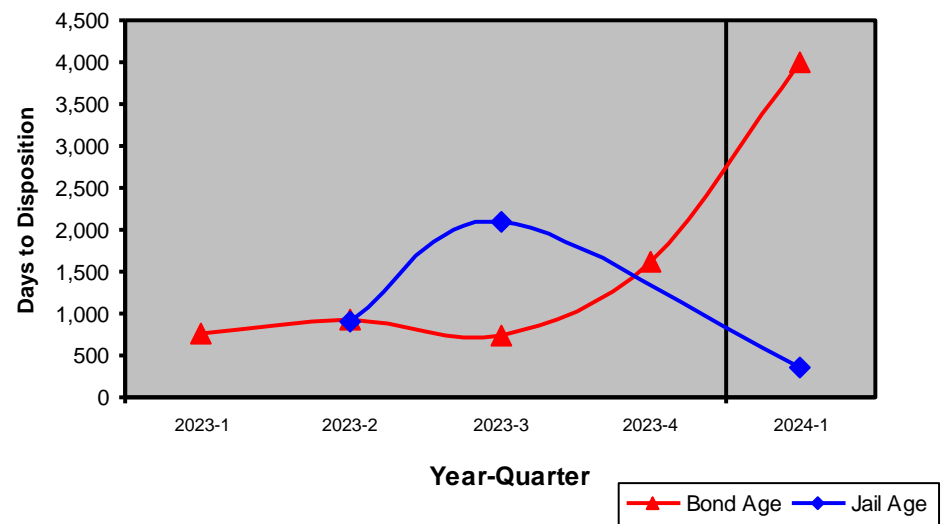
Disposed Without a Trial Average Days to Disposition



Disposed by Trial Number of Cases

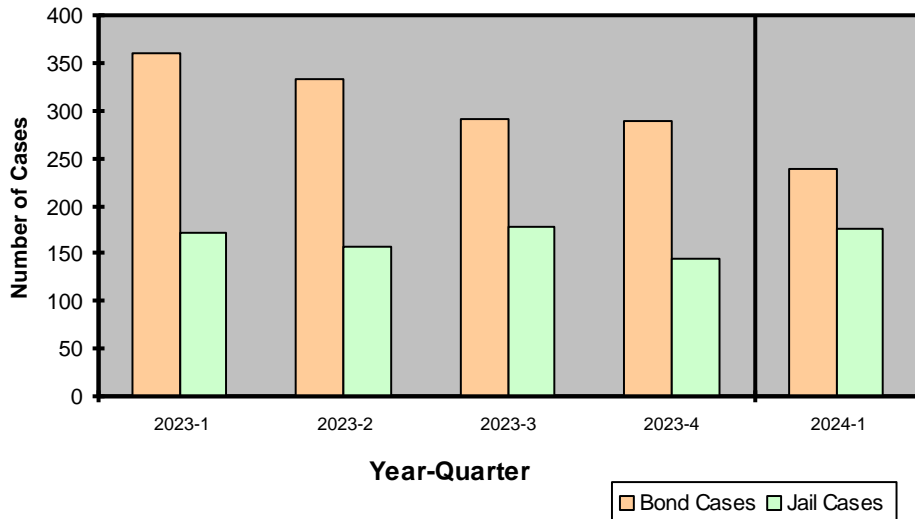

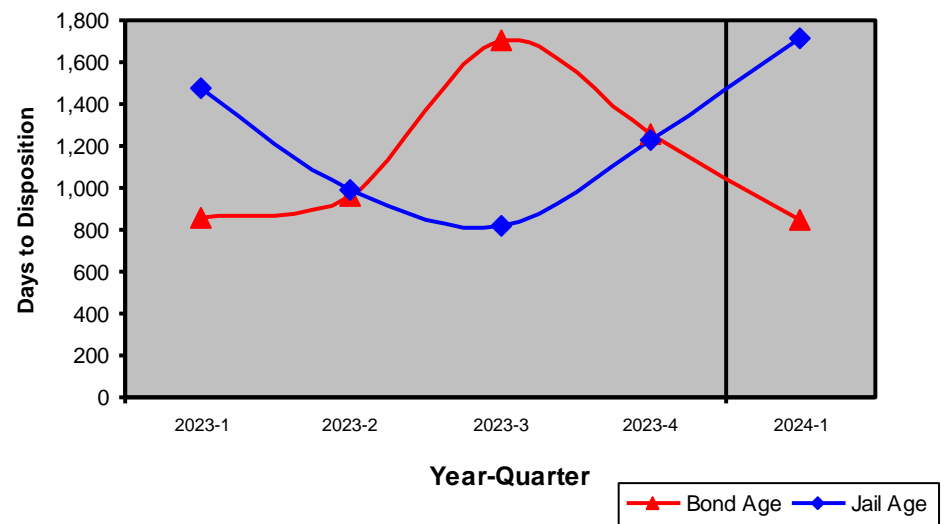
**Disposed Without a Trial
Average Days to Disposition**



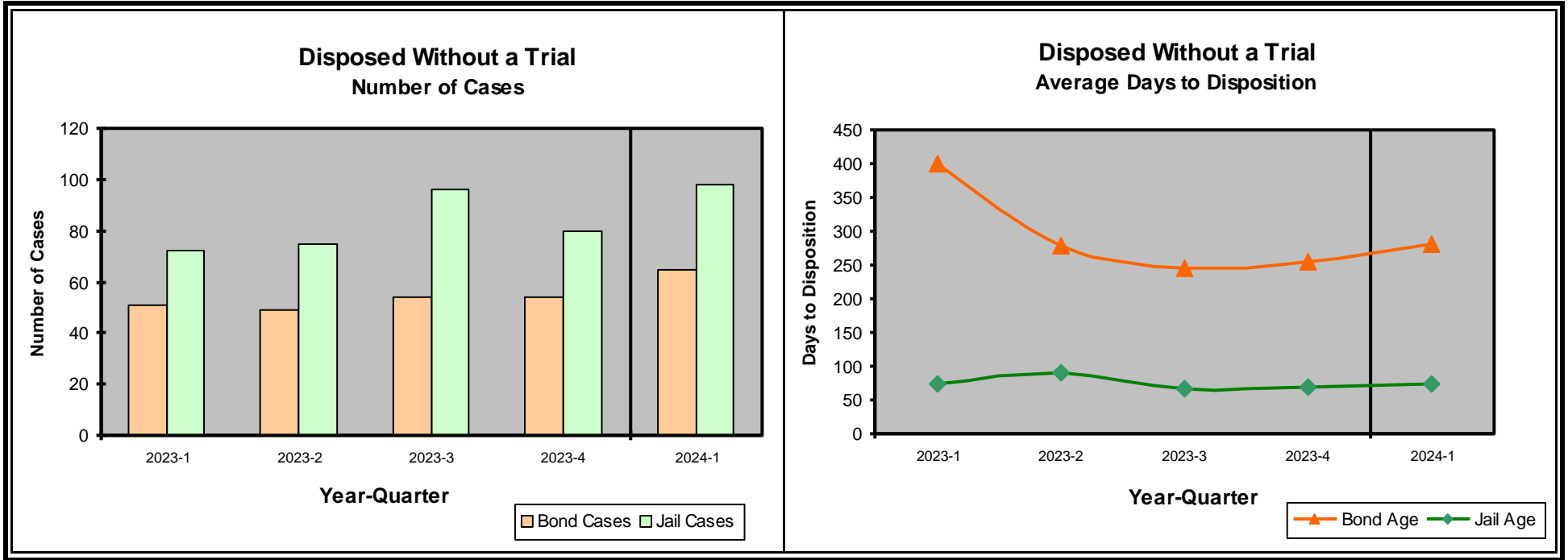

Notes:

1. This report is provided on a quarterly basis as a management tool to criminal justice leaders. The purpose of this report is to assist court managers and judges in monitoring the flow of cases through the court system. Successful case flow management can help avoid and reduce unnecessary delay as well as allow more efficient use of time and other resources. This report was developed using guidelines established by the National Center for State Courts. It provides statistics on the average time it takes cases to move from arrest to disposition of the case, for the current year compared to the same time period in the previous year. This analysis is also available by Criminal Court Division.
2. For this report, an outlier test procedure of two standard deviations from the mean is used to determine extreme values which could skew the statistics. Two standard deviations around the mean account for roughly 95 percent of the data population. Values that are determined to be outside two standard deviations are excluded from the statistical calculations. Therefore, the number of cases and defendants reported here is not intended to represent the total number of cases and defendants disposed during the time period.
3. Criminal Court cases are included in this report when all counts for a defendant are disposed. Each defendant is analyzed separately. Therefore, a Criminal Court case can be included in more than one time period if there are multiple defendants with their final count disposed in different quarters.
4. Concerning data on jury trials: This report provides data on the average length of time to dispose a case/defendant therefore it does not include when a jury mistrials and the case remains open. It is also unable to distinguish when a defendant enters a guilty plea after a jury has been impaneled for a trial. At this time the data in CJIS provides no way to accurately identify those cases that started, but did not end, as a jury trial, nor measure the time spent in a trial prior to the guilty plea. Therefore in this report trial cases are defined as cases disposed and recorded in CJIS with disposition by either jury trial or bench trial.
