
To vote for a candidate whose name is not printed on the ballot, touch "Write-In" and touch keyboard will appear. Type the candidate's name and touch "Accept."

Touch "Review Ballot" on the last ballot page to review your selections.


To change vote, touch the name or issue on the "Review Ballot" page or step back through the ballot using the "Previous Page" in the lower left corner of the screen.
