*Dear Oak Hill Voter,*

Early voting for the June 7, 2016, City of Oak Hill Municipal Election will be held at the satellite office location of the Davidson County Election Commission located at 800 2nd Av. S. 4th Floor, Nashville, Tennessee. The dates and hours for early voting are as follows:

**May 18, 2016, through June 2, 2016**

**The DCEC will be closed on Monday, May 30 2016 in observance of a legal holiday (Memorial Day)  
Monday through Friday-8:00 a.m. to 4:30 p.m.**

**Federal or Tennessee Government Issued Photo ID is required to vote unless exception applies**

The Polling location on Election Day, Tuesday, June 7, 2016 is Brentwood Hills Church of Christ, 5120 Franklin Pike, Nashville, Tennessee. The poll will be open from 7:00 a.m. to 7:00 p.m.

Name and address changes or other registration record modifications must be made at or received by the Davidson County Election Commission by **4:30 p.m. on Thursday, June 2, 2016.**

**EMERGENCY VOTING:** Persons entering a hospital between Wednesday, May 18, 2016, and the morning of Tuesday, June 7, 2016, and who are unable to vote in person on Election Day, should call the office of the Davidson County Election Commission at (615) 862-8815 for emergency Absentee Voting Registrars to provide ballots and voting assistance. The call must be received at the commission office no later than 7:00 a.m. on Tuesday, June 7, 2016 (Election Day).

**An eligible voter may be able to vote absentee by personal appearance at the Commission office during the period of June 2, 2016 to June 6, 2016, under the following circumstances:**

- 1. Due to the death of a relative of a voter which would result in the voter's absence from the county on Election Day;**
- 2. If the voter receives a subpoena or services of process requiring the voter's presence on Election Day.**

To vote as stated above, the voter shall show reasonable proof to the Administrator of Elections or Deputy. The above two (2) categories are in addition to those persons or categories of persons otherwise authorized to vote absentee as set forth in T.C.A. 2-6-101.
