

MINUTES
METROPOLITAN SEXUALLY ORIENTED
BUSINESS LICENSING BOARD

The Sexually Oriented Business Licensing Board held its regularly scheduled meeting on January 11, 2012 at 5:00 pm. Members Blake Freeman, Johnny Crumby Sr. and Kenya Hall were present. Members Alan Johnson and Worrick Robinson were absent. Attorney Jennifer Cavanaugh and Inspector Christine Gibson were present. The meeting was called to order at 5:00 p.m. by Vice Chairman Blake Freeman.

Mr. Crumby made the motion to approve the minutes for the meeting of December 14, 2011. Ms. Hall seconded the motion and the Board voted unanimously.

The meeting for December 28, 2011 was cancelled and therefore the following new entertainer permit applications from December 15, 2011 to December 28, 2011 were approved pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2): 1841 and 1842. In addition, the following entertainer renewal permits were approved: 3, 7, 211 and 283 pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2)

Ms. Gibson informed the Board that the following entertainer permit applications were in order from December 29, 2011 to January 11, 2012: 1844, 1845, 1846, 1847, 1848, 1849 and 1850. Mr. Crumby made the motion to approve the permits. Ms. Hall seconded the motion and the Board voted unanimously. Ms. Gibson informed the Board that the following entertainer renewal permit applications were in order from December 29, 2011 to January 11, 2012: 236, 380, 1076, 1448 and 1696. Mr. Crumby made the motion to approve the permits. Ms. Hall seconded the motion and the Board voted unanimously.

Ms. Gibson informed the Board that there were no new business license applications from December 15, 2011 to December 28, 2011. Ms. Gibson informed the Board that the renewal application for #1637, Video XXXpress was approved pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2).

Ms. Gibson informed the Board that there were no new business license applications from December 29, 2011 to January 11, 2012 and that the renewal application for #1684, Cabaret Royale was in order. Mr. Crumby made the motion to approve the renewal license application. Ms. Hall seconded the motion and the Board voted unanimously.

Ms. Gibson advised that the following businesses were in compliance during regular inspections: Brass Stables Cigar Bar and Jockey Club, Cabaret Royale, Gabrielle's VIP Club, Pure Gold's Crazy Horse, Déjà vu of Nashville, Hustler Hollywood, Jenna's Toy Box (Dickerson Road), Jenna's Toy Box (Gallatin Pike), Lion's Den, Miranda's Nashville, Miranda's West, Suga's Videos and Gifts and Video XXXpress. Mature Essentials is closed for business.

The Board elected new Officers. Mr. Crumby made a motion to reinstate Mr. Johnson as the Chairman of the Board. Ms. Hall seconded the motion and the Board voted unanimously. Mr. Crumby made a motion to reinstate Mr. Freeman as the Vice Chairman of the Board. Ms. Hall seconded the motion and the Board voted unanimously.

This concluded our business. Mr. Crumby made the motion to adjourn. Ms. Hall seconded. The Board voted unanimously and we adjourned at 5:06 pm until the meeting of January 25, 2012 at 5:00 pm.
