GSD MULTI-PURPOSE IMPROVEMENT BONDS OF 1990

The GSD Multi-purpose Improvement Bonds of 1990 Fund was established to account for the use of bond proceeds for the construction and equipping of various public projects including the following departments and component units: Metropolitan Clerk, General Services, Finance, Sheriff, Police, Fire, Social Services, Library, Public Works, Traffic and Parking, Parks and Recreation, Port Authority, Metro Area Computer Mapping and Metropolitan Transit Authority.

GSD MULTI-PURPOSE IMPROVEMENT BONDS OF 1999

The GSD Multi-purpose Improvement Bonds of 1999 Fund was established to account for the use of bond proceeds for constructing, improving and equipping the Metropolitan Courthouse, a Visual Arts Center, the new library, and various other facilities of the Government.

GSD PUBLIC IMPROVEMENT BONDS OF 1996, SERIES A

The GSD Public Improvement Bonds of 1996, Series A Fund was established to account for the use of bond proceeds for the construction, equipping, and/or improving of various public projects including the following departments and component units: Municipal Auditorium, Parks, Police, Metropolitan Transit Authority, General Hospital, Sheriff, General Services, Convention Center, Public Works, and Sports Authority.

GSD COURTHOUSE RENOVATION CAPITAL OUTLAY NOTES

The GSD Courthouse Renovation Capital Outlay Notes Fund was established to account for the use of note proceeds for Courthouse space renovation and office computerization for the Register of Deeds.

GSD MULTI-PURPOSE IMPROVEMENT BONDS OF 1997A

The GSD Multi-purpose Improvement Bonds of 1997A Fund was established to account for the use of bond proceeds for the construction, equipping, and/or improving of various projects including the following departments and component units: General Services, Justice Information System, Library, Parks, Public Works, General Hospital, and Metro Transit Authority.

GSD PUBLIC IMPROVEMENT STADIUM REVENUE BONDS, SERIES 1996

The GSD Public Improvement Stadium Revenue Bonds, Series 1996 Fund was established to account for the use of bond proceeds for the acquisition of land, relocation of businesses and clearing of land for the construction of the football stadium and for related infrastructure improvements. This fund is a blended component unit of the Government.

GSD ARENA PUBLIC IMPROVEMENT BONDS OF 1996A

The GSD Arena Public Improvement Bonds of 1996A Fund was established to account for the use of bond proceeds for improving and equipping the Nashville Arena.

GSD REDEVELOPMENT BONDS OF 1999

The GSD Redevelopment Bonds of 1999 Fund was established to account for the use of bond proceeds for the purchase of certain land and improvements within the Central State Redevelopment Plan and the preparation of that land for redevelopment.

GSD SCHOOL MULTI-PURPOSE IMPROVEMENT BONDS OF 1997A

The GSD Multi-purpose Improvement Bonds of 1997A Fund was established to account for the use of the bond proceeds for the construction and equipping of improvements to the public school system of the Government.

GSD SCHOOL MULTI-PURPOSE IMPROVEMENT BONDS OF 1999

The GSD School Multi-purpose Improvement Bonds of 1999 Fund was established to account for the use of bond proceeds for constructing, improving and equipping various facilities of the Metropolitan Board of Education.

GSD SCHOOL MULTI-PURPOSE CAPITAL OUTLAY NOTES OF 1998

The GSD School Multi-purpose Capital Outlay Notes of 1998 Fund was established to account for the use of note proceeds for various school projects.
