NOTE: "Security Posture" is the overall security strategy for the protection of people and property. It is the combination of elements to include physical security, security staff and security management.

Negative impact is any event or occurrence that creates a security vulnerability or degrades security in any way or directly leads to injury to a person, or loss and/or damage to property. Examples include compromised security devices (broken security cameras, missing locks, unsecured doors, etc.), open security posts, vehicle accidents, thefts, assaults, etc.
