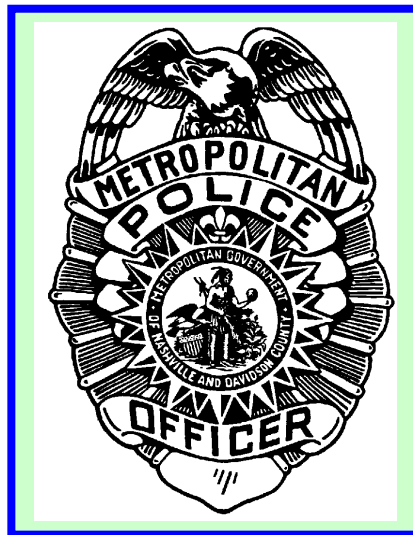

## ISSUE STATEMENTS

### **Issue Statement One**

As the demand increases for accountability of performance by the public, government will increase its awareness of police performance and raise the level of acceptable standards for the quality of the department's service.

### **Issue Statement Two**

The changing and increasingly multi-cultural populations in Nashville will result in a demand for more specialized services, more diversified workforce and more efficient utilization of departmental resources.

### **Issue Statement Three**

The changing and increasing demands on the criminal justice, health and social services infrastructure will result in early release of criminals, lack of drug and mental health treatment, a backlog in the Courts, all of which impacts the department's ability to enforce the law and problem solve and increases the amount of time officers spend on non-law enforcement activity.

### **Issue Statement Four**

As Nashville and surrounding counties become more one (1) community, criminal mobility increases, as does the demand for law enforcement services. The MNPDP must meet this demand.

### **Issue Statement Five**

With increasing participation by citizens in neighborhood groups and an expectation of partnerships with the department, a demand for resources skilled in the community policing philosophy and practices will be expected.

### **Issue Statement Six**

As the new generation of employees becomes more demanding, this will result in challenges for the department in the areas of recruitment, retention, management, training and challenging job assignments.

### **Issue Statement Seven**

Changing technologies and methodologies will enhance the ability of the law enforcement agencies to solve more crimes and to provide improved services to the community.

### **Issue Statement Eight**

An increase in the availability of real time information will allow a more timely and accurate deployment of resources, officers and communication with the public.

**Issue Statement Nine**

Continued changing crime trends in areas such as terrorism, violent crimes, drug abuse, computer crimes, and others, will challenge the department's ability to allocate human and other resources and may divert focus away from current community law enforcement efforts.



## **STRATEGIC GOALS**

- Goal One** By 2012, the crime rate , as defined as the reduction in reported incidents utilizing UCR data, will be reduced by:  
1.5% in the occurrence of violent crimes  
5% in the occurrence of property crimes  
6% in the total Part I crimes reported
- Goal Two** By 2012, community policing, defined as trust, communication, and partnerships between the Police Department and the community, will be evidenced by 85% of the community reporting they feel safe in there homes and neighborhoods.
- Goal Three** The MNPD will increase its efforts to establish trust and communication within its culturally diverse communities by building partnerships with community groups and maintaining a proactive and aggressive recruitment strategy.
- Goal Four** By 2012, the rate of cases solved (as measured by the clearance level) for targeted crimes will be as follows: Compared to 2010 figures  
7% increase for forcible rape cases  
16% increase burglary cases  
12% increase homicide cases
- Goal Five** The traffic fatality rate will be decreased 2% by 2012.
- Goal Six** The implementation of the Advanced Records Management System (ARMS) will enable the dissemination/exchange of information within the department more quickly and efficiently, enabling field based reporting and resulting in a more efficient document flow process, reduced information errors, and an increase in time officers can devote to proactive policing in our neighborhoods.
