

The Metropolitan Nashville Government Employee Flood Relief Grant

Questionnaire

INSTRUCTIONS: The Metropolitan Nashville Government Employee Flood Relief Fund is designed to help any Metropolitan Nashville Government employee who has experienced an economic impact of \$250 or more by the recent flooding in Middle TN. Examples of such expenses incurred could include but are not limited to damage or loss of employee's primary residence, property, vehicle, clothing, or expenses of temporary housing and other basic living expenses. Any employee who has incurred an expense of \$250 or more must complete this questionnaire by June 30th to be considered for a grant. All employees who are actively employed are eligible for grant consideration. Contract and temporary workers are not eligible for grant consideration.

GRANTS: The Metropolitan Nashville Government Employee Flood Relief Fund is a one-time grant (not a loan) to help offset some of your expenses incurred by the recent flood. **Questionnaires must be submitted no later than June 30, 2010.**

Grants cannot be used to pay for expenses such as legal fees, insurance premiums, credit card bills (other than covered expenses listed above), car payments, home foreclosure, accumulated financial distress, and accidental damages due to negligence.

All grant questionnaires will be reviewed after June 30 by the United Way of Metropolitan Nashville. All applicant information and grants awarded will be kept confidential. The United Way of Metropolitan Nashville is administering the collection of contributions and the disbursement of grants. Contributions to fund these grants will come from other employees. If you are approved for a grant, a check payable to the employee will be mailed to the address provided below.

The amount of grant to be awarded will be determined by the United Way of Metropolitan Nashville based on the total contributions collected, the number of employees who meet the above guidelines, and the overall severity of losses, as determined by previous FEMA grants received by the employee completing the questionnaire.
