# About our agency...

The Metropolitan Action Commission is the designated community action agency for Nashville and Davidson County charged with eliminating the barriers of poverty with the ultimate goal of moving families out of poverty. Using a two-generation, whole-family approach as well as an integrated service model to build a system of care for families with limited incomes, we serve an average of 40,000 families. The agency is also recognized nationally for its early adaptation of 2Gen/Whole family approach and its impact on families in moving them out of poverty.

Our Head Start and Early Head Start program is the largest provider of early childhood education for children birth to five in Davidson County. This program promotes school readiness for children from families with low incomes through education, health, social and other comprehensive services. Community Services provides high school equivalency/GED test preparation and college readiness classes and support. The agency also assists families with utility, mortgage and rent payments, prescription costs, utilities and rental deposits for residents, property tax assistance for senior citizens and youth programs through our Summer Food Service Program and our Summer Youth Technology Camp. Our Summer Cooling program provides air conditioning units at no cost to residents with medical conditions during months when the city historically experience extreme The MAC 4 Jobs Program provides heat conditions. workforce development initiatives to increase the earning potential of families within Head Start and Early Head Start programs.

Our agency employs an average of over 400 staff at 8 locations throughout the county. We receive funding from The U.S. Department of Health and Human Services, U.S. Department of Agriculture, U.S. Department of the Treasury, the State of Tennessee, the City of Nashville and Davidson County and Piedmont Natural Gas. The board is comprised of 16 members (Commissioners) from the communities served by the agency as well as appointed members by the city Mayor.

#### A Look back on a Unique Year in Nashville 2020-2021

What an unusual year it has been for Early Education in Nashville Davidson County amid the unprecedented COVID 19 pandemic and on the heels of a devastating tornado. The program set forth with determination to balance safety while continuing to address the developmental and support needs of our children and families. The year began with an all virtual/remote model where children were provided technology and filtered Wi-Fi devices as needed to engage in learning at home called **Remote Interactions and** Supportive Engagement (RISE) with teaching Families teams. were provided meals either by pick up or delivery for the week by our nutrition and transportation teams. Families were also engaged through virtual workshops and other activities. When the local COVID numbers improved, the program moved to a hybrid model (**HyRISE**) where children were engaged on site 2-3 days per week with the remining days being virtual. Parents that needed on-site learning due to work or school were offered 5 days on site for their children. During month of June. the a special enrichment experience summer (Summer RISE) was offered to our four-year olds and other working families to support school readiness and prepare for full on-site offering In August 2021.

#### **Head Start Guiding Principles**

School readiness is comprised of many elements that are driven by various factors. In order to address these multiple components of school readiness, an ongoing plan for student success which includes the child, the caregiver, and the parent, as well as a connection to home and school environments must be implemented.

- It is essential to meet individual needs through an environment of trust and acceptance that supports and respects gender, culture, language, ethnicity, and structure.
- Parent engagement is a critical component in a child's development and learning experiences.
- Parents are a child's first and most important teachers.
- An alignment of curriculum, instruction and assessments are necessary to effectively support children.
- All children deserve a safe, healthy and high quality, age-appropriate program that fosters an environment of learning which will prepare them for school.

#### **Early Head Start Guiding Principles**

It is important to understand the early experiences of zero to three/infants and toddlers provide the foundation for school succeed. The relationships that infants and toddlers build with warm, responsive and nurturing adults assists their developmental competencies, such as a willingness to learn, developing positive relationships, productively handling stressful situations, and problem solving.

- Social-emotional development raises cognitive development.
- Positive relationships empower learning.
- Relationships open the door to curriculum delivery.
- Children are supported when teachers provide support to parents.
