Weaknesses

Failed to provide requested information for previous contracts/projects completed within the past five years. Referenced projects not of a similar scope, size, and complexity. Did not include a copy of offeror's business license. Did not provide information related to access to underwriters. Did not detail offeror's ability to obtain renewal quotes within 60 day of request.
