CALL MEETING TO ORDER

Mr. Reed called the meeting to order.

APPROVAL OF MINUTES

A **motion** to approve meeting minutes for November 8, 2022, was made, seconded, and carried.

NEW BUSINESS

Discussion on Annual Comprehensive Financial Report

Mr. Crosslin went over the Fiscal Year 2022 Annual Comprehensive Financial Report (ACFR) results. Mr. Crosslin discussed the timeline of the remaining reports for the year. Council Member Hurt inquired about the State Comptroller's concerns in prior years. Mr. Crosslin explained the previous issue was regarding compliance in 2020 of tax anticipation notes. However, the government has complied since 2021. Council Member Hurt inquired about how the report received the Government Finance Officers Association award with financial troubles in the past. Ms. Kaufman explained that the award is given based on the organization and presentation of the ACFR. The award does not evaluate the financial information provided or the financial state of the government. Vice Mayor Shulman noted a typo and asked questions regarding the financial information of specific line items in various statements presented. Ms. Kaufman, Mr. Crosslin, and Mr. Hunt addressed the questions. Council Member Hurt asked additional questions related to the underlying reasons for changes in specific line items. Mr. Crosslin and Ms. Kaufman addressed each question.

A **motion** to accept the Fiscal Year 2022 Annual Comprehensive Financial Report was made, seconded, and carried.
