SUBJECT: June 12, 2023, Traffic and Parking Commission Agenda Analysis

**PURPOSE**:

Provide an overview of all items on the upcoming Metropolitan Traffic and Parking Commission agenda to ensure that commission members have the information necessary for discussion and action prior to the commission meeting.

Commissioners are encouraged to contact Nashville Department of Transportation (NDOT) staff prior to the meeting with any questions.

### STAFF ANALYSIS:

### **Consent Agenda**

4.01 CD 22: Authorization to reduce posted speed limit on US Hwy 70S between Saddle Ridge Ct and US Hwy 70 (Charlotte Pike) from 50 mph to 40 mph, SR 1641058.

Analysis: The Major and Collector Street Plan designates Hwy 70S as T3-R-AB2-S, a scenic two-lane arterial boulevard. Configured with two 12-ft travel lanes, this street is constructed with a rural ditch section, no sidewalk, and no bicycle lanes. The segment of Hwy 70S between Hwy 70 and Saddle Ridge Ct has a posted speed limit of 50 mph. Beyond these limits to the south, the posted speed limit is 40 mph from Saddle Ridge Ct to I-40. To the north, US Hwy 70S ends at US Hwy 70 (Charlotte Pike) with a posted 50 mph speed. A new traffic signal is under construction for the driveway to James Lawson School, which intersects with this segment of US Hwy 70S.

With the addition of a new signal for the school driveway, new bus routes, and new school traffic, the posted speed limit should be reduced on this road segment to 40 mph.



Recommendation: Authorize 40 mph posted speed limit on US Hwy 70S from Saddle Ridge Ct to US Hwy 70.

5.01 Events needing Metro Employees Assistance.

Analysis: This item is to apprise the Commission of requests for fee waivers for use of Metro's parking garages as well as bagged meter requests. The NDOT policy for waiving parking fees was approved by the Commission at the September 12, 2022, meeting and is reproduced below.

#### 2023 upcoming special events involving a fee waiver:

Music City July 4th Celebration – The Nashville Convention & Visitors Corp requests complementary parking in the Public Square Garage for Metro's annual July 4 event. Note that this current request is the identical to the one made for prior years' July 4 events. Complementary garage parking for the 2022 July 4 event was approved by the Commission at the June 13, 2022 meeting.

Approval for complementary parking for the 2023 July 4 event requires T&P authorization at the June 12, 2023, meeting.

John Lewis Way Procession has become an annual event on Rep John Lewis Way between Jefferson St and Commerce St. The Mayor's Office of Film and Special Events indicates that the 2023 event application fee has been waived at the request of Deputy Mayor Haywood. Fifteen parking meters are installed along this route. A bagged meter fee waiver is requested for the upcoming July 15, 2023, event.


Approval for this fee waiver will require T&P authorization at the June 12, 2023, meeting.


#### Recommendations:

Approve fee parking fee waiver for Metro Public Square Garage for the 2023 July 4 event, running from July 2 through July 5.

Approve a bagged parking meter fee waiver for the John Lewis Way procession for Rep John Lewis Way between Jefferson St and Commerce St for the July 15, 2023 special event.

5.02 CD 19: Authorization to revoke existing valet lane and replacement with new ride share parking regulation at 501 Commerce St, requested by NDOT, SR 1711956.





Analysis: The existing rideshare parking at 501 Commerce was approved on the south side of Commerce St at the July 2021 T&P meeting. Located about 50 feet west of Rep John Lewis Way, the rideshare parking space is about 25 ft in length and is bookended by a one-space valet lane to the east and a garage driveway ramp to the west. The current signage reads RIDESHARE PARKING ONLY 15 MIN LIMIT.

The existing valet lane was approved at the August 2021 T&P meeting at the request of Premier Parking. This valet lane is no longer in use and the valet fee has not been paid.

Approval of this request will remove the valet lane and replace with a single rideshare curbspace, approximately 45 ft in length +/-.

Recommendation: Authorize revocation of existing valet lane and replacement with rideshare pickup & drop-off only at 501 Commerce St.

# Metro Nashville Residential Parking Permit Application

- 1. Permits will expire on December 31st and must be renewed by permit holder annually by January 10th. Renewal fee is \$30.00, payable to the Nashville Department of Transportation and Multimodal Infrastructure.
- 2. Permits are not transferable and are valid only in the area specified and only for the vehicle described on the permit.
- 3. Permits are enforced by License Plate Recognition also known as LPR.
- 4. Proof of residency for the residential permit area that an applicant is applying for must be submitted with the application for a permit to be issued.




Figure 1-Map of parking zones presented at December 2022 Traffic & Parking Commission.

#### **New Business**

7.01 Sidewalk vending & new TN law regulating hemp-derived cannabinoids.

This item is to apprise the Commission of a recent change to Tennessee law.

On May 11, 2023, Governor Lee signed SB 0378 to regulate the sale and distribution of products containing a hemp-derived cannabinoid.

With the passage of this law, it becomes a class A misdemeanor to knowingly distribute samples of products containing a hemp-derived cannabinoid in or on a public street, sidewalk, or park. The effective date of this section of the legislation is July 1, 2023.
