Minutes

May 25, 2023

The Metropolitan Nashville-Davidson County Transportation Licensing Commission (TLC) met for its regular meeting on this date in the Jury Assembly Room of the Historic Davidson County Courthouse. Present were Vice Chair Pat McNally (Acting chair), Commissioners Keith Pyle, Freddy Carr, Carey Rogers, Carol Westlake, Michael Hayes, and Michael Santistevan (7). Present were NDOT/TLC staff members Diana Alarcon, Lisa Steelman, T.D. Schlafer, Richard Rooker and Billy Fields. Also present were Metro Legal advisor Theresa Costonis.

The Chair called the meeting to order then led the Pledge of Allegiance followed by a reading of the Notice of Appeal Statement which outlined the right of appeal of TLC decisions.

Commissioner Pyle with a second from Commissioner Rogers moved approval of the meeting minutes from the previous meeting.

After some discussion, Commissioner Rogers with a second from Commissioner Santistevan moved to approve the new OPVH company applications, changes requested by OPVH applicants as well as the new wrecker/towing companies.

ACTION: Approved 4-0

Executive Secretary Fields advised the TLC that the Shared Urban Mobility Device (SUMD) companies one-year contracts as well as the Certificate for Public Convenience and Necessity expires in June. NDOT staff recommended renewal of both. After some discussion, Commissioners Carr with a second from Commissioner Rogers moved to renew the SUMD contract along with the Certificate of Public Convenience and Necessity for one year.

ACTION: Approved 4-0

Executive Secretary Fields introduced proposed routes for Entertainment Transportation vehicles and Pedal Carriages during the Broadway viaduct construction closure. He requested that by June 12 the industry and public respond in writing with their feedback. NDOT Director Alarcon stated that 25,000+ vehicles would need to be routed in another direction daily and added this proposed operational route would be temporary based upon suggestions of NDOT engineering and feedback from the industry. Director Alarcon asked that the operators keep in account the people who live and work downtown and ask they be respectful of the noise they create.

Commissioners Hayes and Westlake arrived during the proposed route discussion.

Dangelo Boyd applied for a permit to be an Other Passenger Vehicle for Hire driver. After some discussion, Commissioner Carr with a second from Commissioners Westlake moved to approve the application with a stipulation that the applicant must submit to a random drug test at his cost during the licensure period.

ACTION: Approved 4-2

Adam Mercado Ferrer applied to be an OPVH driver. After discussion, Commissioner Hayes with a second from Commissioner Pyle moved to deny the application.

ACTION: Denied 6-0
