## 1. CALL TO ORDER

Chairman John Green called the meeting of August 14, 2023, to order at 3:00 p.m. Chairman John Green announced the appeals process, Metropolitan Code of Laws 2.68.030.

"If you are not satisfied with a decision made by the Traffic & Parking Commission, you may appeal the decision by filing for a writ of certiorari with the Davidson County Chancery or Circuit Court. Your appeal must be filed within 60 days of the date of the entry of the Commission's decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met."

"Per the Tennessee Open Meetings Act, Public Chapter No. 300, members of the public are invited to provide comment on matters germane to the items on the agenda."

### 2. APPROVAL OF AGENDA

Commissioner Woods moved for approval of the agenda, seconded by Commissioner Tefel. The agenda was approved with no objection.

### **3. APPROVAL OF MINUTES**

- 3.01. Approval of minutes from July 10, 2023.
  - Commissioner Woods moved for approval of the July 10th minutes. Commissioner Mason seconded the motion. The motion was approved with no objections.

### 4A. PUBLIC COMMENTS

 Pastor Jonathan Nash of the Napier Kitchen Table working with the JC Napier Homes Community spoke to the need for crosswalks on Lafayette and Murfreesboro Pike at Lewis Street. They have a new community facility and would like a safe crossing space for members of the community. Nicole Vaughn Valentine also requested that staff prioritize a safe crossing at this corridor.

Carol Morton requested that the narrow street policy be revised. She would like no parking along narrow stretches of the road on South 9<sup>th</sup>. Please consider changing the policy. Council Member Henderson asked for clarification on the request. Ms. Morton is looking for a revision of the Narrow Street Policy. She would like no parking on narrow streets.

  - Commissioner Woods requested item 4.03 be moved to regular agenda. Commissioner Tefel seconded the motion. The motion was approved with no objections.
  - Commissioner Woods moved to approve the consent agenda. Council Member Henderson seconded the motion. The motion was approved with no objections.

### 5. REGULAR AGENDA

- 4.03 CD 25: Sharondale Drive speed reduction from Woodlawn Drive to Hillsboro Pike, requested by NDOT.
  - Commissioner Woods and Council Member Henderson proposed that the speed limit be lowered to 25 MPH. Discussion
    was had surrounding the proposal. Commissioner Tefel also supported the 25 MPH proposal. Director Alarcon provided a
    point of information surrounding surplus funding, this funding will be available in January to make appropriate markings for
    school zones. Commissioner Woods moved to approve a 25 MPH speed limit on Sharondale from Woodlawn Drive to
    Hillsboro Pike. Council Member Henderson seconded the motion. The motion was approved with no objections.
- 5.01. CD 32: Appeal of new parking restrictions on Bridgecrest Dr, requested by homeowners.
  - Jason Oldham of NDOT provided background surrounding the original request and referenced the NDOT policy for Narrow Streets. Homeowners Fernando Reyes and Tremaine Ricketts voiced concerns surrounding the parking restriction. Council Member Styles spoke to the safety concerns in the cul-de-sac and gave background on this safety issue stating with parking on the street, emergency vehicles are unable to respond. Commissioner Brown made a motion to remove the signs. No second to that motion. Additional discussion was had. Council Member Henderson made a motion to deny the repeal. No second to that motion. Commissioner Tefel felt that we needed a fair compromise. Director Alarcon reiterated the Narrow Street Policy, best practices and peer benchmarking when making the decision. Legal interjected additional clarification. Commissioner Mason made a motion that what staff had previously decided stand but that additional conversations with the community be had. If it is determined no parking on both sides of the street was still warranted that a discussion be had regarding alternate parking considering the messaging and notifications that were sent out could have been better. Council Member Henderson seconded the motion. The motion was approved with no objections.
- 5.02. CD 32: Authorization for new traffic signal at Bell Rd & Arbor Common/Beechwood Terrace, requested by NDOT.
  - Jason Oldham gave background surrounding the analysis of crash data for this intersection. The intersection did meet the criteria for the safety warrant for traffic signals. We are looking for you to approve a signal at this location. Council Member Styles spoke in support of the signal and provided additional background regarding the need. Commissioner Woods moved to approve. Commissioner Brown seconded the motion. Council Member Henderson asked about the challenges for the street in its entirety. Do we have any additional signals or road diets planned for this road. Director Alarcon spoke to a partnership that is happening with WeGo to identify a long-range plan to make improvements as we grow. We are working to build a balanced transportation system and Bell Road is a priority. Council Member wants to ensure we are not precluding public transit in the future. The motion was approved with no objections.
- 5.03. CD 19: Authorization for new valet lane on the Southwest side of 11<sup>th</sup> Ave S, requested by Jarred Colin. Jason Oldham gave background surrounding the expired moratorium and a wish to reenact. Council Member Henderson asked for clarification regarding the legality of reenacting an expired moratorium. Director Alarcon spoke to the Connect Downtown study and the recommendations coming out of the study. Mr. Cloin spoke to the parking issue and the simplicity of the valet request. Director Alarcon spoke to further valet discussion in the future. Jason Oldham clarified that the valet would be 2 spaces from 4pm to 11pm. Council Member Henderson moved to approve. Commissioner Tefel seconded the motion. The motion was approved with no objections.
- 5.04. CD17: Authorization for new passenger loading zone for 747 Fesslers Lane/Enos Reed Dr, requested by Tan Assets LLC The requestor asked that this item be deferred. Commissioner Mason motioned for a deferral. Commissioner Tefel seconded the motion. The motion was approved with no objections.

        opening soon and would most likely request a valet zone in this area. Council Member Henderson moved to
        approved ecommerce meters until a valet stand is applied for. Commissioner Mason seconded the motion. The
        motion was approved with no objection.

      - Director Alarcon spoke to the need for additional meters on this street. Commissioner Woods moved to approve. Council Member Henderson seconded the motion. The motion was approved with no objection.

      - Director Alarcon spoke to creating afterhours (6pm to 7am) paid parking. We are looking to do paid parking until Connect Downtown Recommendations can be implemented. Council Member Henderson is looking for vertical measures to help with sight line for crosswalks. Council Member Henderson moved to approve. Commissioner Woods seconded the motion. The motion was approved with no objections.

<u>Traffic and Parking Commission Authority:</u> Chapter 9 of the Metropolitan Charter, Sec. 11.904. - Function of commission as to traffic regulation.

For the purpose of making the roads, streets, and other public ways safe for pedestrians, motorists and others, and for the purpose of facilitating the flow of traffic thereon, the commission is hereby authorized to adopt and publish traffic regulations, including the erection of proper signs necessarily and properly connected with or incident to the following:

(a)The location and time when parking shall be limited.(b)Places where parking shall be prohibited entirely or only during certain hours.(c)The establishment of stop sign controls for through streets or isolated intersections.(d)The establishment of traffic signal controls.(e)The direction in which traffic may use any street or portion of a street.(f)Restrictions on the size of vehicles using certain streets.(g)The establishment of speed zones upon metropolitan streets and roads based upon the findings of the commission. When such zones are properly signposted, the speed indicated on the signs shall be the legal speed limit.

Such traffic regulations adopted by the commission shall take effect five (5) days after they have been published in a daily newspaper of general circulation within the area of the metropolitan government and after a certified copy thereof has been filed with the metropolitan clerk and the chief of police. Such regulations, when so adopted, shall have the force and effect of an ordinance, and shall be enforced by the metropolitan police. The metropolitan council shall provide by ordinance for the punishment of violators of such traffic regulations and shall fix proper and adequate fines and penalties.
