**QUALIFYING DEADLINE FOR CANDIDATES** is Thursday, August 17, 2006, at 12:00 Noon. Candidates should file nominating petitions with the Administrator of Elections, Davidson County Election Commission.

**WITHDRAWAL DEADLINE FOR CANDIDATES** to remove his or her name from the ballot is Thursday, August 24, 2006, at 12:00 Noon. A withdrawal must be in writing and signed by the candidate.

**LAST DAY TO REGISTER IN PERSON TO VOTE** for this election is Saturday, October 7, 2006, at 4:00 p.m.

**LAST DAY TO MAIL IN YOUR APPLICATION (BY-MAIL)** for this election is Sunday, October 8, 2006. All By-Mail Registration Applications must be postmarked by this date. Anyone who registers by mail must vote the first time in person whether on election day or during early voting.

**LAST DAY FOR NAME CHANGE, ADDRESS CHANGE,** or to make any other alteration to the registration record is Thursday, November 2, 2006. Applicants may register to vote or make changes at the Davidson County Election Commission, located at 800 2nd Avenue South, First Floor, Nashville, Tennessee, or by using an Application By-Mail Registration form available at the D.C.E.C. Office, Public Library or Post Office locations.

**The Davidson County Election Commission office** hours are Monday through Friday, 8:00 a.m. to 4:30 p.m. weekdays.
