QUALIFYING DEADLINE FOR CANDIDATES is WEDNESDAY, SEPTEMBER 13, 2006, at 12:00 NOON. Candidates should file nominating petitions with the Administrator of Elections, Davidson County Election Commission, Metro Office Building, 800 2nd AV S, Nashville, Tennessee.

WITHDRAWAL DEADLINE FOR CANDIDATES to remove his or her name from the ballot is **WEDNESDAY, SEPTEMBER 20, 2006, at 12:00 NOON.** The request to withdraw must be in writing, signed by the candidate and filed with the Davidson County Election Commission.

LAST DAY TO REGISTER IN PERSON TO VOTE for this election is **SATURDAY, OCTOBER 7, 2006, at 4:00 p.m.**

LAST DAY TO REGISTER BY MAIL for this election is **SUNDAY, OCTOBER 8, 2006.** Applications must be postmarked by this date. Registration by mail forms are available at the **D.C.E.C.** office or at public library branches. Each person who registers by mail shall appear in person to vote in the first election the person votes in after such registration becomes effective. Such person shall present satisfactory proof of identity.

LAST DAY FOR ADDRESS OR NAME CHANGE is **THURSDAY, NOVEMBER 2, 2006.**
