NOTICE IS HEREBY GIVEN THAT an election for the City of Lakewood will be held on Tuesday, June 5, 2007, to elect two (2) City Commissioners to four (4) year terms.

QUALIFYING DEADLINE FOR CANDIDATES is Thursday, March 15, 2007, at 12:00 Noon. Candidates should file nominating petitions with the Administrator of Elections, Davidson County Election Commission.

WITHDRAWAL DEADLINE FOR A CANDIDATE to remove his or her name from the ballot is Thursday, March 22, 2007, at 12:00 Noon. A withdrawal must be in writing and signed by the candidate.

LAST DAY TO REGISTER IN PERSON TO VOTE for this election is Saturday, May 5, 2007, 9:00 a.m. to 12 Noon.

LAST DAY TO MAIL IN AN APPLICATION (BY-MAIL) TO REGISTER for this election is Sunday, May 6, 2007. All By-Mail Registration Applications must be postmarked by this date. **ANYONE WHO REGISTERS BY MAIL MUST, BY LAW, VOTE THE FIRST TIME IN PERSON WHETHER ON ELECTION DAY OR DURING EARLY VOTING.**

LAST DAY FOR NAME CHANGE, ADDRESS CHANGE, or to make any other alteration to the registration record is Thursday, May 31, 2007. Applicants may register to vote or make changes at the Davidson County Election Commission, located at 800 2nd Avenue South, First Floor, Nashville, Tennessee, or by using an Application By-Mail Registration form available at the Davidson County Election Commission Office, Public Library, Post Office, and Department of Safety and Vehicle Registration locations.

ALL REGISTERED VOTERS OF DAVIDSON COUNTY WHO HAVE MOVED WITHIN THE COUNTY OR HAD A NAME CHANGE ARE ENCOURAGED TO MAKE THESE CHANGES AS SOON AS POSSIBLE. VOTERS WHO FAIL TO DO SO PRIOR TO ELECTION DAY WILL EXPERIENCE A DELAY IN VOTING.
