## **Amendment to the Minutes for the June 18, 2019, Metropolitan Council Meeting**

Mr. President:

### **Bill BL2019-1624**

A bill to be entitled: The Budget Ordinance of the Metropolitan Government of Nashville and Davidson County, Tennessee for Fiscal Year 2020.

The bill was approved with a substitute by the Budget and Finance Committee. Council Member Elrod moved to defer the bill, which motion was properly seconded. After discussion, Council Member Sledge called for the previous question, which motion was seconded and approved by a voice vote of the Council. Mr. President –

I move to amend Ordinance No. BL2019-30 as follows:

I. By amending Section 1 by adding the underlined text in the following:

Section 1. That Metropolitan Code Subsection 16.04.200(B) is hereby amended by inserting new subsections 3 and 4 as follows and renumbering the subsequent sections accordingly:

3. Within the Urban Zoning Overlay (UZO), barbed wire and razor wire fencing shall be prohibited along arterial and collector roadways as defined by the adopted Major & Collector Street Plan; provided, that this section shall not be construed to prevent anyone from stretching a single strand of barbed wire on the top of any fence over seven feet high to prevent anyone from climbing over the same.
4. Within the Urban Services District, barbed wire and razor wire fencing along sidewalks shall be regulated by Metropolitan Code Section 13.32.120 in addition to the regulations in this section.

Mr. President –

I hereby move to amend Ordinance No. BL2019-75 by deleting Section 1 in its entirety and substituting in lieu thereof the following:

Section 1. That Chapter 2.30 of the Metropolitan Code of Laws is hereby amended by creating new Sections 2.30.050 and ~~2.30.060~~ as follows:

2.30.050 Training.

- A. All 9-1-1 telecommunicators who provide dispatch for emergency conditions shall be required to be trained, ~~utilizing the most current, nationally recognized emergency cardiovascular care guidelines, in high quality~~ in telecommunicator cardiopulmonary resuscitation (T-CPR). This training shall be approved by the director and selected utilizing the most current, nationally recognized, evidence-based emergency cardiovascular care guidelines. At a minimum, this training shall incorporate recognition protocols for out-of-hospital cardiac arrest, compression-only cardiopulmonary resuscitation (CPR) instructions for callers, and continuous education as appropriate.
- B. The department shall establish a procedure for monitoring adherence by identified telecommunicators ~~and the governing bodies of identified telecommunicators~~ to the requirements set forth in Subsection A and shall conduct ongoing quality assurance of its dispatcher-assisted bystander cardiopulmonary resuscitation program and may adjust grant/shared revenue amounts based on failure to comply with the requirements of this Section.

~~2.30.060 Civil Immunity~~

- ~~A. No 9-1-1 telecommunicator who instructs a caller on telecommunicator cardiopulmonary resuscitation (T-CPR) shall be liable for any civil damages arising out of the instruction provided to the caller, except for acts or omissions intentionally designed to harm, or for grossly negligent acts or omissions that result in harm to an individual.
  - ~~1. A caller may decline to receive telecommunicator cardiopulmonary resuscitation (T-CPR) instruction.~~
  - ~~2. When a caller declines telecommunicator cardiopulmonary resuscitation (TCPR) instruction, the 9-1-1 telecommunicator has no obligation to provide the instruction.~~~~
- ~~B. The department shall not be liable for any civil damages for employing individuals to answer 9-1-1 emergency calls who are recently hired, onboarding, and not currently trained in high quality telecommunicator cardiopulmonary resuscitation (T-CPR) training.~~
