SUMMARY

CORRECTIONAL POPULATION PROJECTIONS:

- By 2024 there will be an estimated 2,050 average daily population in Davidson County correctional facilities. That is an annual decrease of 0.8% on average during the projection period, 2020-2024. The ADP was 2,644 in 2015 and declined an average 5.2% each year through 2019. Assuming current capacity levels, the correctional system will be operating at an estimated 59.3% capacity in 2024 (*pages 14, 17*).
- Male inmates are projected to decline an average 0.9% each year during 2020-2024, to reach a projected daily population of 1,785. Female inmates are projected to decline 0.2% annually, to an average 265 per day (*pages 15-16, 22-25*).
- By 2024 there will be an estimated 861 pretrial felons in the average daily jail population, an annual +1.1% growth. Pretrial misdemeanants will decline 0.7% per year to 87. Other charge classes with notable average daily populations in 2024: locally sentenced felons (456; -4.1% annually), state sentenced felons (164; +1.5%), convicted misdemeanants (228; -2.2%) (*pages 17-21*).
- Male charge classes with the largest populations in 2024 are pretrial felons with an estimated ADP of 756 (+0.9% annually), and locally sentenced felons with an ADP of 410 (-4.0%). Female pretrial felons will comprise 105 of the average daily population in 2024, +2.8% annual growth. Female convicted misdemeanants (47; +2.0% annually) and female locally sentenced felons (45; -4.0%) are the other large charge classes (*pages 22-25*).

DAVIDSON COUNTY POPULATION:

- Davidson County's population grew an average 1.27% per year from 2010-2019. The population was estimated at 703,466 for 2019, and is projected to steadily grow 1.1% per year through 2024, reaching 732,892 Davidson County residents (*pages 4-5, 26*).
- The portion of the population most at risk for arrest, ages 18-45, is expected to grow an average of 1.0% per year through 2024. The 15-17 portion of the population is expected to grow an average of 1.3% annually with males at an average of 1.2% and females at an average annual increase of 1.4% (*pages 5, 26*).

REPORTED CRIME:

- Reported crime in Davidson County increased 0.6% in 2019 compared to 2018. Violent crimes decreased 3.0%, while property crimes increased 1.6%. Overall, reported crime has been declining in Davidson County in the past 10 years (*pages 6, 27*).

ARRESTS:

- In 2019 there were 24,860 adult physical arrests in Davidson County, a 21.9% decrease from 2018. The number of State Citations issued in 2019 decreased 55.7% from 2018, to 12,448 (*page 7*).


ADMISSIONS AND RELEASES:

- In 2019 admissions to Davidson County correctional facilities decreased 26.1% below 2018 levels. Admissions have decreased an average of 6.1% between 2010 and 2019. The average length of stay in 2019 for inmates increased from 24.9 days in 2018 to 30.1 days in 2019 (*page 11*).
- Releases from Davidson County correctional facilities decreased 22.6% in 2019. Bond releases decreased 20.9% and releases to the Pretrial Release program decreased 12.0% in 2019 (*pages 11-12*).

AVERAGE DAILY CORRECTIONAL POPULATION:

- The average daily correctional population was 2,132 in 2019 which was 6.0% less than in 2018 when the population averaged 2,267. The ADP has declined an average of 5.2% since 2010(*pages 8-10*).
- Davidson County correctional facilities operated at 62% capacity in 2019, which was a decrease from 2018 when the capacity was 66%. It is important to note that in 2019, the Offender Reentry Center (ORC) only held inmates January through April (*page 8*).



2010 – 2024**











MALE INMATES







2015-2024**



2015-2024




