Dear Voter,

Early voting for the September 19, 2017, Special Runoff Election for Council District 33 (unexpired term) will be held at the MAIN office of the Davidson County Election Commission, located at 1417 Murfreesboro Pk. (Genesco Park). The dates and hours for early voting are as follows:

August 30, 2017 through September 14, 2017

Mondays, Wednesdays and Fridays 8:00 a.m. to 4:30 p.m.

Tuesdays and Thursdays 8:00 a.m. to 6:30 p.m.; and Saturdays, 8:00 a.m. to 12:00 NOON

The DCEC will be closed on Monday, September 4, 2017, in observance of the Labor Day holiday

Federal or Tennessee Government Issued Photo ID is required to vote unless exception applies

The polling locations on Election Day, Tuesday, September 19, 2017, are as follows:

- 33-1 Eagle Christian Church, 1795 Baker's Grove Rd.
- 33-2 Thomas Edison Elementary School, 6130 Mt. View Rd.
- 33-3 New Antioch High School, 1900 Hobson Pk.
- 33-4 Gilroy Church of Christ, 13126 Old Hickory Bv.

The polling locations on Tuesday, September 19, 2017, will be open from 7:00 a.m. to 7:00 p.m.

Name and address changes or other registration record modifications must be made at or received by the Davidson County Election Commission by **4:30 p.m. on Thursday, September 14, 2017.**

EMERGENCY VOTING: In accordance with T.C.A. 2-6-401, persons entering a hospital between Wednesday, August 30, 2017, and the morning of Tuesday, September 19, 2017, and who are unable to vote in person on Election Day, should call the office of the Davidson County Election Commission at (615) 862-8815 for emergency Absentee Voting Registrars to provide ballots and voting assistance. The call must be received at the commission no later than 7:00 a.m. on **Tuesday, September 19, 2017**, (Election Day).

An eligible voter may be able to vote absentee by personal appearance at the main office of the Davidson County Election Commission office during the period of September 14, 2017 to September 18, 2017, under the following circumstances:

1. Due to the death of a relative of a voter which would result in the voter's absence from the county on Election Day;
2. If the voter receives a subpoena or services of process requiring the voter's presence on Election Day.

To vote as stated above, the voter shall show reasonable proof to the Administrator of Elections or Deputy. The above two (2) categories are in addition to those persons or categories of persons otherwise authorized to vote absentee as set forth in T.C.A. 2-6-101.
