Firm provided resumes for all key personnel for this project. Firm provided requested certifications for this project. Firm provided five reference projects of similar size, scope and complexity with valid contact information.

##### Weaknesses

Firm's proposal lacked details for installation process. Firm's proposal lacked details for emergency support process. Firm's proposal lacked details for assuring an environmentally friendly project. Firm's proposal lacked details for assuring quality management.

### **Beacon Technologies**

#### **Strengths**

Firm's proposal identified proposed team members for this project. Firm provided resumes for key personnel for this project.

#### **Weaknesses**

Firm failed to provide required Corning Certification.

### **Boe-Tel TN Co.**

#### **Strengths**

Firm's proposal provided detailed installation process to include termination and labeling practices. Firm's proposal provided detailed service ticket strategy. Firm provided detailed testing process to include sample tests. Firm's proposal provided detailed approach to assure quality management for this project. Firm's proposal provided a detailed recycling policy to assure each project resulting from this solicitation will be environmentally friendly. Firm provided resumes of key personnel for this project. Firm provided requested certifications for this project. Firm provided reference projects of similar size, scope and complexity with valid contact information.

#### **Weaknesses**

Firm's proposal lacked detail for emergency response process.

### **M3 Technologies**

Firm's proposal lacked detail for installation process. Firm's proposal lacked details for emergency response process. Firm's proposal lacked details for service ticket strategy. Firm failed to provide outdoor cabling project reference scope of work.

## **Pro Systems Inc.**

### **Strengths**

Firm's proposal demonstrated detailed core drilling capabilities to include owning core drilling equipment. Firm's proposal demonstrated detailed service ticket strategies. Firm demonstrated detailed testing process to include sample tests. Firm's proposal provided detailed information to assure quality management to include inspections and timelines. Firm's proposal provided detailed recycling policy to assure each project resulting from this solicitation will be environmentally friendly.

### **Weaknesses**

Firm's proposal lacked detail for emergency response process. Firm's proposal lacked detailed information for key personnel. Firm's proposal failed to identify proposed team members for scope of work in this solicitation. Firm's proposal lacked detail for reference contact information, to include dollar amount, and dates of submitted projects.

## **Stansell Electric Co.**

### **Strengths**

Firm identified proposed team for this project. Firm provided resumes for key personnel. Firm's proposal demonstrated detailed core drilling capabilities to include owning core drilling equipment. Firm's proposal demonstrated detailed quality management approach to include random site visits and inspections during installation. Firm's proposal provided detailed recycling policy to assure each project resulting from this solicitation will be environmentally friendly.

### **Weaknesses**

Firm's proposal lacked subcontractor information for team qualifications. Firm's proposal lacked detail in emergency support process for this solicitation. Firm's proposal lacked details for service ticket strategy. Firm's proposal failed to follow requested proposal submittal format. Firm's proposal failed to provide reference project dates.
