Strengths: Detailed demonstration of firm's knowledge of state laws, Tennessee 1 calls, and rules and regulations pertaining to underground locating; detailed risk mitigation plan; detailed quality management approach.

Weaknesses: Failed to demonstrate firm's knowledge and experience in locating underground water and sewer infrastructure; failed to demonstrate firm's success in locating underground water and sewer infrastructure; failed to demonstrate firm's relevant project experience; key individuals lacked relevant project experience; projects of similar size, scope, and complexity; firm's demonstration of efficient use of team members lacked detail; failed to identify potential issues/challenges within the scope; failed to provide an approach to minimize any disruptions and a comprehensive plan for completing the specified work in accordance with the scope; contract exceptions.

USIC Locating Services LLC (71.00 Points)

Strengths: Detailed demonstration of firm's knowledge and experience in locating underground water and sewer infrastructure; detailed demonstration of firm's success in locating underground water and sewer infrastructure; detailed demonstration of firm's knowledge of state laws, Tennessee 1 calls, and rules and regulations pertaining to underground locating; relevant project experience for key individuals; projects of similar size and complexity; detailed quality management approach; detailed risk mitigation plan; detailed demonstration of the firm's knowledge of the project objectives/goals; detailed demonstration of firm's efficient use of team members and technology for completing the project.

Weaknesses: Failed to provide the minimum number of projects of similar scope; cost; contract exceptions.

Utiliquet (72.00 Points)

Strengths: Detailed demonstration of firm's knowledge of state laws, Tennessee 1 calls, and rules and regulations pertaining to underground locating; projects of similar size and complexity; detailed risk mitigation plan; detailed quality management approach involving GPS vehicle locating devices; detailed demonstration of efficient use of technology necessary for completing project efficiently.

Weaknesses: Failed to demonstrate firm's knowledge and experience in locating underground water and sewer infrastructure; project experience of key individuals lacked detailed; firm's demonstration of success in locating underground water and sewer infrastructure lacked detail; organizational chart lacked detail; failed to provide the minimum number of projects of similar scope; demonstration of the firm's knowledge of the project objectives/goals lacked detail; failed to demonstrate efficient use of team members; sixty (60) day implementation plan.
