

MINUTES  
METROPOLITAN SEXUALLY ORIENTED  
BUSINESS LICENSING BOARD

The Sexually Oriented Business Licensing Board held a meeting on October 9, 2019 at 4:00 p.m. Members Jonathan Richardson, Tiffany Gray and Leneiva Head were present. Member Cullen Earnest was absent. Attorney Justin Marsh and Inspector Christine Gibson were present. Chairman Jonathan Richardson called the meeting to order at 4:11 p.m.

Ms. Gibson advised the Board that member Kyonzte Toombs resigned because she was elected to the Metro Council and can no longer serve on this board.

Ms. Head made the motion to approve the minutes for the meeting of August 14, 2019. Ms. Gray seconded the motion and the Board voted unanimously.

The meeting for August 28, 2019 was canceled; therefore, the following new entertainer permit applications from August 15, 2019 to August 28, 2019 were approved pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2): 3039, 3040, 3041, 3042, 3043, 3044, 3045, 3046, 3047 and 3048. In addition, the following renewal entertainer permit applications were approved: 133, 143, 654, 1050, 1788, 1803, 1901, 2086, 2126, 2551, 2759 and 2851.

The meeting for September 11, 2019 was canceled; therefore, the following new entertainer permit applications from August 29, 2019 to September 11, 2019 were approved pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2): 3049, 3050, 3051, 3052, 3053, 3054, 3055, 3056, 3057 and 3058. In addition, the following renewal entertainer permit applications were approved: 1280, 1907, 1954, 2099, 2495, 2499, 2698, 2717, 2820 and 2874.

The meeting for September 25, 2019 was canceled; therefore, the following new entertainer permit applications from September 12, 2019 to September 25, 2019 were approved pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2): 3059, 3060, 3061, 3062, 3063, 3064 and 3065. In addition, the following renewal entertainer permit applications were approved: 21, 2118, 2127, 2383, 2493, 2553, 2592, 2626, 2708, 2880 and 2888.

Ms. Gibson informed the Board that the following new entertainer permit applications were in order from September 26, 2019 to October 9, 2019: 3066, 3067, 3068, 3069, 3070, 3071, 3072, 3073, 3074 and 3075. Ms. Head made the motion to approve the permits. Ms. Gray seconded the motion and the Board voted unanimously.

Ms. Gibson informed the Board that the following renewal entertainer permit applications were in order from September 26, 2019 to October 9, 2019: 1385, 1403, 1472, 1616, 1730, 2728 and 2732. Ms. Head made the motion to approve the permits. Ms. Gray seconded the motion and the Board voted unanimously.

Ms. Gibson informed the Board that there were no new business license applications and no renewal business license applications.

Ms. Gibson presented her Inspector's report to the Board. She advised that the following businesses were in compliance during regular inspections: Pure Gold's Crazy Horse, Déjà vu of Nashville, Jenna's Toy Box (Dickerson Road), Jenna's Toy Box (Gallatin Pike), Lion's Den and Miranda's Nashville.

The board discussed the frequency of canceling meetings due to lack of quorum and the possibility of moving the meeting date or time. No solution was reached at the time.

This concluded their business. Ms. Head made the motion to adjourn. Ms. Gray seconded. The Board voted unanimously and adjourned at 4:27 p.m. until the meeting of October 23, 2019 at 4:00 p.m.
