**PARTICIPATION AGREEMENT  
FOR  
SEWER SERVICE**

THIS AGREEMENT is entered into by and between Laura Wilhite hereinafter known as "WILHITE", and The Metropolitan Government of Nashville and Davidson County acting through the Metropolitan Department of Water and Sewerage Services, hereinafter known as "METRO"

WHEREAS, WILHITE has expressed a desire to provide public sewer service system improvements in the Stonebrook Subdivision Section 13-C, Project No. 98-SL-088A ; and

WHEREAS the Stonebrook Subdivision Main Sewer Pump Station requires upgrading Project No. 99-SL-84 as a result of this project and others; and

WHEREAS, it is deemed in the best interest of the public to construct said improvements, and WILHITE is agreeable to paying its proportionate share of the cost of the upgrades in the amount of \$2,500; and

WHEREAS, this work is identified in METRO's Capital Improvement Budget as CIB No. 01-SG-002;

NOW, THEREFORE, WILHITE AND METRO AGREE AS FOLLOWS:

I. PAYMENT TERMS AND CONDITIONS:


WILHITE agrees to reimburse a proportionate share of the construction costs of downstream sewerage system extensions in the amount of \$2,500 as a contribution-in-aid of construction for improvements designated as Project No. 99-SL-84. This amount to be held in escrow pending Metro Council Approval


II FUTURE AMENDMENTS:

Any future amendments to this ordinance may be approved by resolution of the Metropolitan Council,

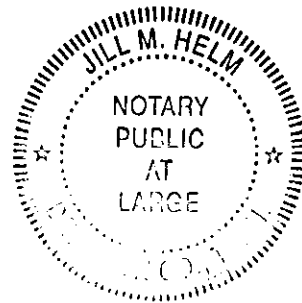





**PARTICIPATION AGREEMENT  
FOR  
SEWER SERVICES**

THIS AGREEMENT is entered into by and between Laura Wilhite, hereinafter known as "WILHITE", and The Metropolitan Government of Nashville and Davidson County acting through the Metropolitan Department of Water and Sewerage Services, hereinafter known as "METRO"

WHEREAS, WILHITE has expressed a desire to provide public sewer service system improvements in the Stonebrook Subdivision, Section 13-C, Project No. 98-SL-088A; and

WHEREAS METRO has funded the Upper Mill Creek Trunk Sewer Project No. 98-SG-13 anticipating participation from developers at \$2,000 per connection towards the cost of the Upper Mill Creek Project; and

WHEREAS, it is deemed to benefit both parties and the general community, and WILHITE agrees to pay an amount not to exceed \$2,000.00; and

WHEREAS, this work is identified in METRO's Capital Improvement Budget as CIB No. 01SG002;

NOW, THEREFORE, WILHITE AND METRO AGREE AS FOLLOWS:

I. PAYMENT TERMS AND CONDITIONS:

WILHITE agrees to participate in the construction costs of downstream sewerage system extensions in the amount of \$2,000.00 for lots 1322 (866 Dortch Lane) in Stonebrook Subdivision Section 13-C (a total of 1 single-family home connection). METRO will collect and hold this amount in escrow until participation approval by Metro Council.

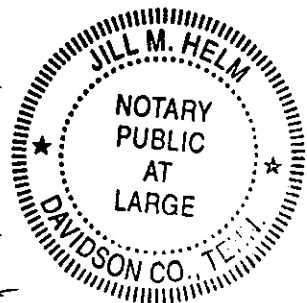
