

Ordinance No. BL2018-1143

An ordinance approving an agreement between the State of Tennessee acting through its Department of Transportation (TDOT), City of Belle Meade, CSX Transportation, and The Metropolitan Government of Nashville and Davidson County, acting by and through its Department of Public Works, for payment to CSXT for costs incurred by CXST during the construction phase of the bridge rehabilitation project at the Hillwood Boulevard bridge over CSX Transportation railroad crossing and Richland Creek, Agreement No. 0981, PIN No. 107669.00, State Project No. 19960-3521-94, Federal Project No. NHZ-9312(80), CSXT OP No: TN0327.

WHEREAS, CSXT has directed TDOT, acting by and through the Metropolitan Government of Nashville and Davidson County Department of Public Works and the City of Belle Meade, for payment to CSXT for costs incurred due to the bridge rehabilitation at the Hillwood Boulevard bridge over CSX Transportation railroad crossing and Richland Creek, Agreement No. 0981, PIN No. 107669.00, State Project No. 19960-3521-94, Federal Project No. NHZ-9312(80), CSXT OP No: TN0327; and,

WHEREAS, The Metropolitan Government of Nashville and Davidson County agrees to cooperate with TDOT, City of Belle Meade, and CSX Transportation in the construction and maintenance of this project, and shall assume ownership and the responsibility of maintenance upon completion of this project, as described in said agreement, attached hereto as Exhibit A and incorporated by reference, so that said construction can occur; and,

WHEREAS, the estimated cost of \$285,847 shall be paid for by the State of Tennessee; and,

WHEREAS, it is in the interest of The Metropolitan Government of Nashville and Davidson County that this construction be carried out.

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section I. That the Agreement with CSXT, attached hereto as Exhibit A and incorporated herein by reference for payment to CSXT for costs incurred due to the bridge rehabilitation at the Hillwood Boulevard bridge over CSX Transportation railroad crossing and Richland Creek, PIN 107669.00, State project no. 19960-3521-94, Federal project no. NHZ-9312(80), CSXT OP #: TN0327, is hereby approved, and that the Metropolitan Mayor is authorized to execute the same.

Section 2. That this ordinance shall take effect from and after its final passage, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.
