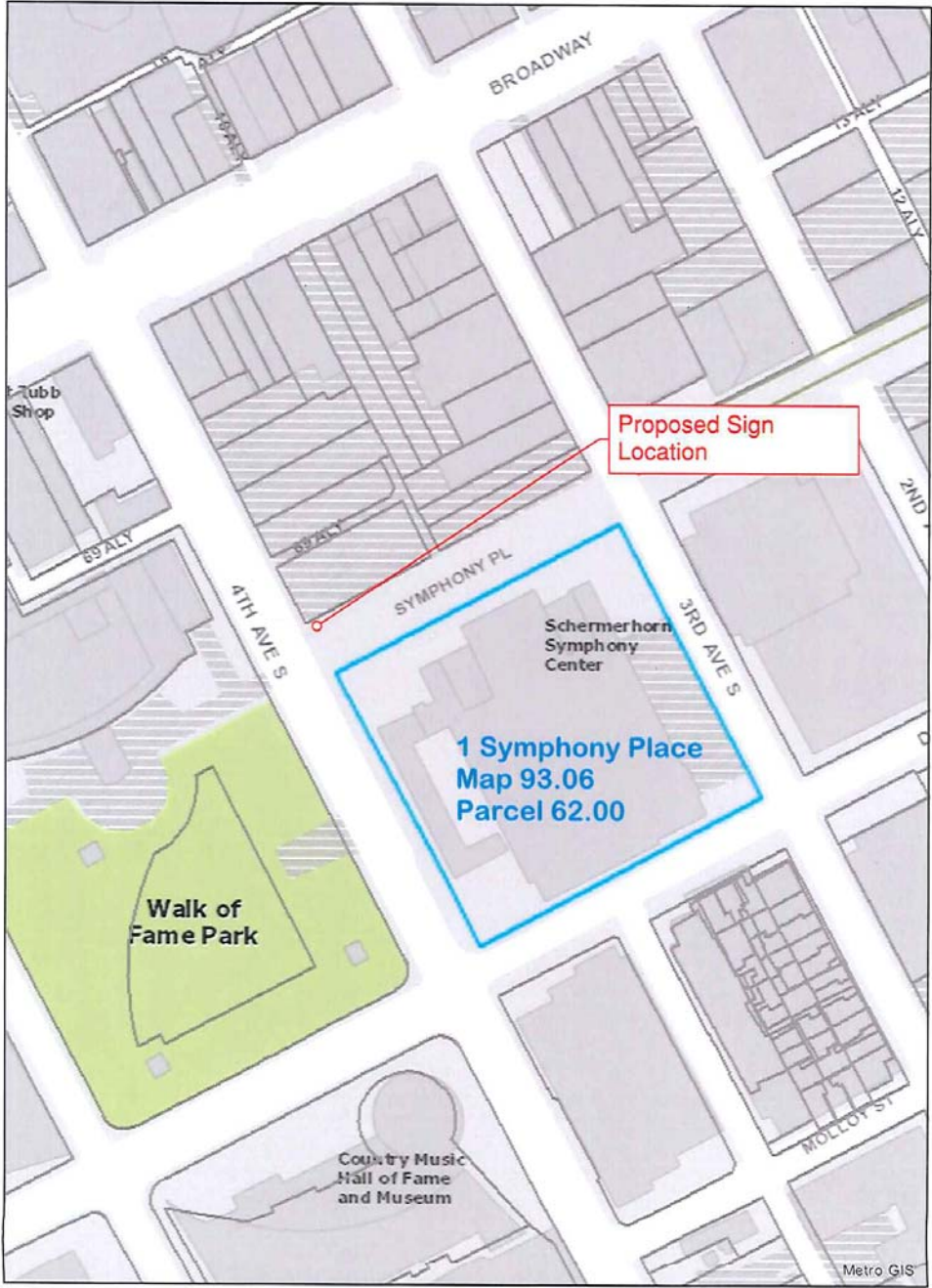
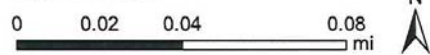


# Nashville / Davidson County Parcel Viewer

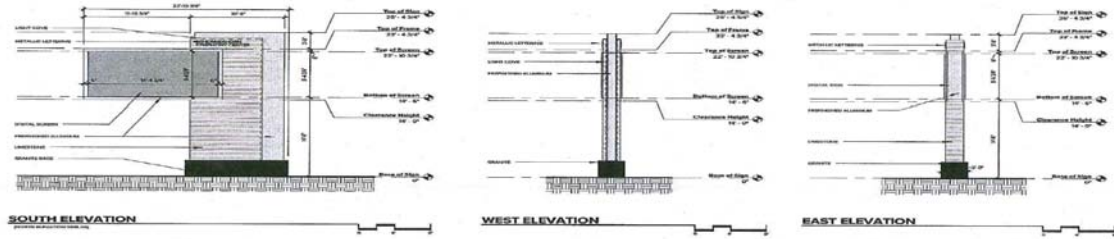
