

RESOLUTION NO. RS2018-1409

A resolution amending Ordinance No. BL2018-1177 to authorize The Metropolitan Government of Nashville and Davidson County to abandon an additional 80 linear feet of existing eight inch sanitary sewer main and easement, for property located at 701 South 7th Street (Proposal No. 2018M-057ES-001, MWS Project Nos. 17-WL-249 and 18-SL-38).

WHEREAS, Ordinance No. BL2018-1177, approved June 6, 2018, authorized the abandonment of approximately 195 linear feet of existing eight inch sanitary sewer main, approximately 786 linear feet of existing six inch water main and easements, and the acceptance of approximately 264 linear feet of new eight inch water main, a fire hydrant and any associated easements, for property located at 701 South 7th Street,

WHEREAS, the abandonment of an additional 80 linear feet of existing eight inch sanitary sewer main and easement, are needed to construct project numbers 17-WL-249 and 18-SL-38; and,

WHEREAS, the Metropolitan Planning Commission approved mandatory referral No. 2018M-057ES-001 on August 1, 2018, for the abandonment of said additional 80 linear feet of existing eight inch sanitary sewer main and easement; and,

WHEREAS, Ordinance No. BL2018-1177 provides that amendments to the legislation shall be approved by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. That Ordinance No. BL2018-1177 is hereby amended by deleting Section 1 in its entirety and substituting in lieu thereof the following:

The Metropolitan Government of Nashville and Davidson County is authorized to abandon approximately 275 linear feet of existing eight inch sanitary sewer main and easement, approximately 786 linear feet of existing six inch water main and easements, and to accept approximately 264 linear feet of new eight inch water main, a fire hydrant and any associated easements, for property located at 701 South 7th Street, as shown on Exhibit 1, which is attached hereto and incorporated by reference

Section 2. The Directors of Water and Sewerage Services and Public Property Administration are authorized to execute such documents as may be necessary and appropriate to carry out the abandonment and acceptance authorized by this ordinance.

Section 3. This resolution shall take effect upon passage, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.
