

**AMENDMENT 1 TO CONTRACT 2019-03
BETWEEN THE
GREATER NASHVILLE REGIONAL COUNCIL
AND
METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY**

The Greater Nashville Regional Council (GNRC) and Metropolitan Government of Nashville and Davidson County, hereinafter referred to as the "Contractor", entered into a contract effective July 1, 2018, for the provision of certain home and community based services based on state funds made available by the state legislature and federal funds, under the Older Americans Act of 1965 as amended, through the Tennessee Commission on Aging and Disability, as further defined in the "SCOPE OF SERVICES;" and:

Section D.2. of the July 1, 2018 contract allows written amendments to the Contract.

The Contract dated July 1, 2018, between GNRC and Metropolitan Government of Nashville and Davidson County is amended as follows:

1. Section C.1, page 1, is amended by deleting the original C.1. and substituting it with the following new C.1.


C.1. Maximum Liability. In no event shall the maximum liability of the GNRC under this Contract exceed Eighty Thousand Dollars (\$ 80,000.00) for FY 2020. Payment for services rendered shall not exceed the per hour rates in Section C.3 and shall constitute the entire compensation due the Contractor for all service and Contractor obligations hereunder regardless of the difficulty, materials or equipment required. The payment rates include, but are not limited to, all applicable taxes, fees, overheads, and all other direct and indirect costs incurred or to be incurred by the Contractor.

The Contractor is not entitled to be paid the maximum liability for any period under the Contract or any extensions of the Contract for work not requested by the GNRC. The maximum liability represents available funds for payment to the Contractor and does not guarantee payment of any such funds to the Contractor under this Contract unless the GNRC requests work and the Contractor performs said work. In which case, the Contractor shall be paid in accordance with the payment rates detailed in Section C.3. The GNRC is under no obligation to request work from the Contractor in any specific dollar amounts or to request any work at all from the Contractor during any period of this Contract.

The parties have caused this Contract Amendment to be executed by officials duly authorized and it becomes effective on July 1, 2019. All other terms and conditions of this Grant Contract not expressly amended herein shall remain in full force and effect.






