

Resolution No. RS2019-1826

A resolution approving amendment one to a grant from the Tennessee Highland Rim Healthcare Coalition to The Metropolitan Government of Nashville and Davidson County, acting by and through the Metropolitan Nashville Fire Department, to fund the purchase of a tent and enclosed trailer, both with HVAC, for large scale events.

WHEREAS, The Metropolitan Government of Nashville and Davidson County, acting by and through the Metropolitan Nashville Fire Department, previously entered into a grant agreement with the Tennessee Highland Rim Healthcare Coalition, approved by RS2019-1739; and,

WHEREAS, the parties wish to amend the grant agreement to extend the grant term from June 30, 2019 to July 31, 2019, a copy of which amendment one is attached hereto; and,


WHEREAS, it is to the benefit of the citizens of The Metropolitan Government of Nashville and Davidson County that amendment one be accepted.

That amendment one to the grant by and between the Tennessee Highland Rim Healthcare Coalition and The Metropolitan Government of Nashville and Davidson County, acting by and through the Metropolitan Nashville Fire Department, to fund the purchase of a tent and enclosed trailer, both with HVAC, for large scale events, a copy of which amendment one is attached hereto and incorporated herein, is hereby approved, and the Metropolitan Mayor is authorized to execute the same.


Section 2. That this resolution shall take effect from and after its adoption, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

Because of circumstances outside of your control this letter is to inform you that an extension has been approved for thirty days (30). Item must be received no later than July 31, 2019.




