

## **TDEC Survey Questions**

1. Are there any policies, statutes, rules, protocols or ordinances that inhibit the county and municipalities from having effective programs? Reference specific statues, rules, policies or documents when answering the question.

68-101-109: Labeling of Plastic Containers - This labeling is not an indicator of recyclability and therefore confusing for our residents as to what is and is not recyclable. They look at that symbol and see it as synonymous with recyclability which has led to both confusion in what plastic is accepted in our program and a lack of confidence and trust in our program that we are not recycling all that we can.

HB 1021 / SB 0431 - This policy specifically prohibits our ability to enact policies recommended in our Solid Waste Master Plan to achieve our goal of Zero Waste. For example, part of our plan includes requiring establishments that serve liquor to have recycling programs for their beverage containers. It also limits our ability to address single-use bags and containers in our local waste stream.

2. Are there any parts or utility of the 10 Year Solid Waste and Materials Management Statewide Plan, Plan Update or Annual Progress Report the county and municipalities do not understand?

3. What role can Materials Management play to be the biggest resource to the county and its municipalities?

Reconvene and refund the top 5 city meetings and regional meetings (GNRC) for solid waste. These meetings are extremely valuable to help solve many of the issues we are all facing with solid waste on a regional level. They allowed us to collaborate, learn from each other, and explore regional solutions to waste management.

4. What is needed in the county and municipalities to further waste reduction, recycling, diversion or end markets in Tennessee?

Non-matching grant funding - Matching grant funds can often be difficult for waste diversion programs and projects most needed for achieving long-term goals. Non-matching grant funding would go a long way to implement solutions for waste diversion.

End markets for materials, especially #5 plastics, rigid plastics, compost, and construction and demolition materials

More financial incentives for infrastructure and end market development - We have limited options for recycling and composting and need a more diverse system of solutions for materials that could be encouraged with financial incentives.

5. §68-211-871(b) requires an annual progress report on the implementation of the regional comprehensive integrated municipal solid waste management plan. What steps are the county and municipalities taking locally to contribute to regional plan implementation?

The Mayor's Administration has formed a Sustainable Advisory Committee that has evaluated our solid waste master plan and prioritized recommendations in that plan to guide the administration in next steps to work towards. We have formed a Steering Committee of experts and stakeholders focused on C&D Waste Reduction to guide Metro's Division of Solid Waste to work towards solutions to keep this material out of landfill. The Division of Solid Waste has had a focus this past year on C&D waste and we are in the process of enacting legislation that would provide funding to implement a more robust waste management plan reporting program for building and demolition projects. This program would provide much needed data on the generation and disposal of C&D waste materials in the county as well as provide opportunities to educate contractors and industry professionals on how to reduce, reuse, or recycle C&D material. We have also been supporting the Tennessee Materials Marketplace working to connect C&D waste generators with recyclers and reuse options. In partnership with the Nashville Food Waste Initiative, we have been supporting efforts to start community composting sites providing supplies, signage, and educational resources.

6. What areas would you like to see the Division of Solid Waste Management focus on in coming years to help the county and municipalities be successful implementing the Region's plan and programs?

More Grant funding.

Economic development - Encourage recyclers and reuse/remanufacturing operations to come into the state to help develop regional infrastructure hubs around the top 5 cities that support waste reduction efforts. This would help build infrastructure networks for recycling and reuse that both Nashville and its surrounding counties could take advantage of. Specifically, it would be helpful to drive more C&D facilities and recyclers for hard to recycle materials to these hubs.

## **About Solid Waste Region Boards**

The 1991 Solid Waste Management Act required Tennessee Counties to form municipal solid waste regions. While some regions are multi-county solid waste regions, many counties in Tennessee formed a single county region. This was the case with Davidson County.

Solid waste regions were required to appoint a board that represented the cities and county within the region and to administer the activities of the solid waste planning region. Members serve for a six-year term (TCA 68-211-813).

The roles of the solid waste region board are the following:

- Create a 10 Year Solid Waste Management Plan to reduce waste entering MSW landfills by 25% and ensure adequate disposal capacity. Each year the region board is required to submit an "Annual Progress Report" the Tennessee Department of Environment and Conservation describing any changes in the 10 Year Plan, current recycling and disposal data and future needs for the region.
- 2. Review permit applications for solid waste disposal facilities or incinerators within the region. The board is required to review the application against the 10 Year Plan and determine whether the application is in compliance with the plan and TCA 68-211-814.
- 3. Flow control or restricting import/export of solid waste across the region's boundaries. Davidson County does not restrict the movement of solid waste.

State law also allowed for the creation of solid waste authorities. Solid waste authorities are entities having administrative, financial and technical power to implement regional solid waste plans and programs. Davidson County did not opt for a solid waste authority.
