# About the Annual Progress Report

- ▶ Counties required to form Solid Waste Regions
- ▶ Solid Waste Regions required to create 10 year plans to divert waste from Class 1 (municipal solid waste) Landfills
- ▶ 10 year plans are updated each year via the Annual Progress Report (APR)
  - ▶ TDEC provides an online portal and format for the APR
- ▶ Nashville's Long-term Zero Waste Master Plan has replaced the previous 10 year plan

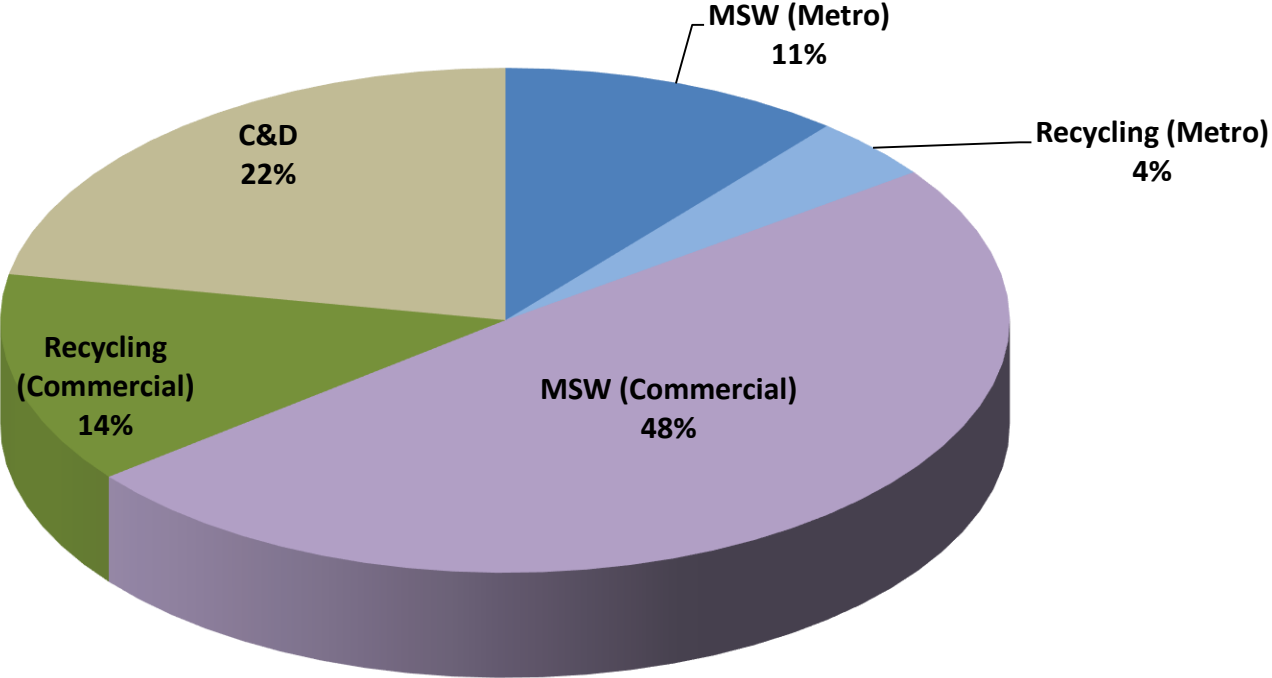
## Organics Drop-offs

- ▶ Metro diverted over 12 tons in 2018 and 23 tons in 2019

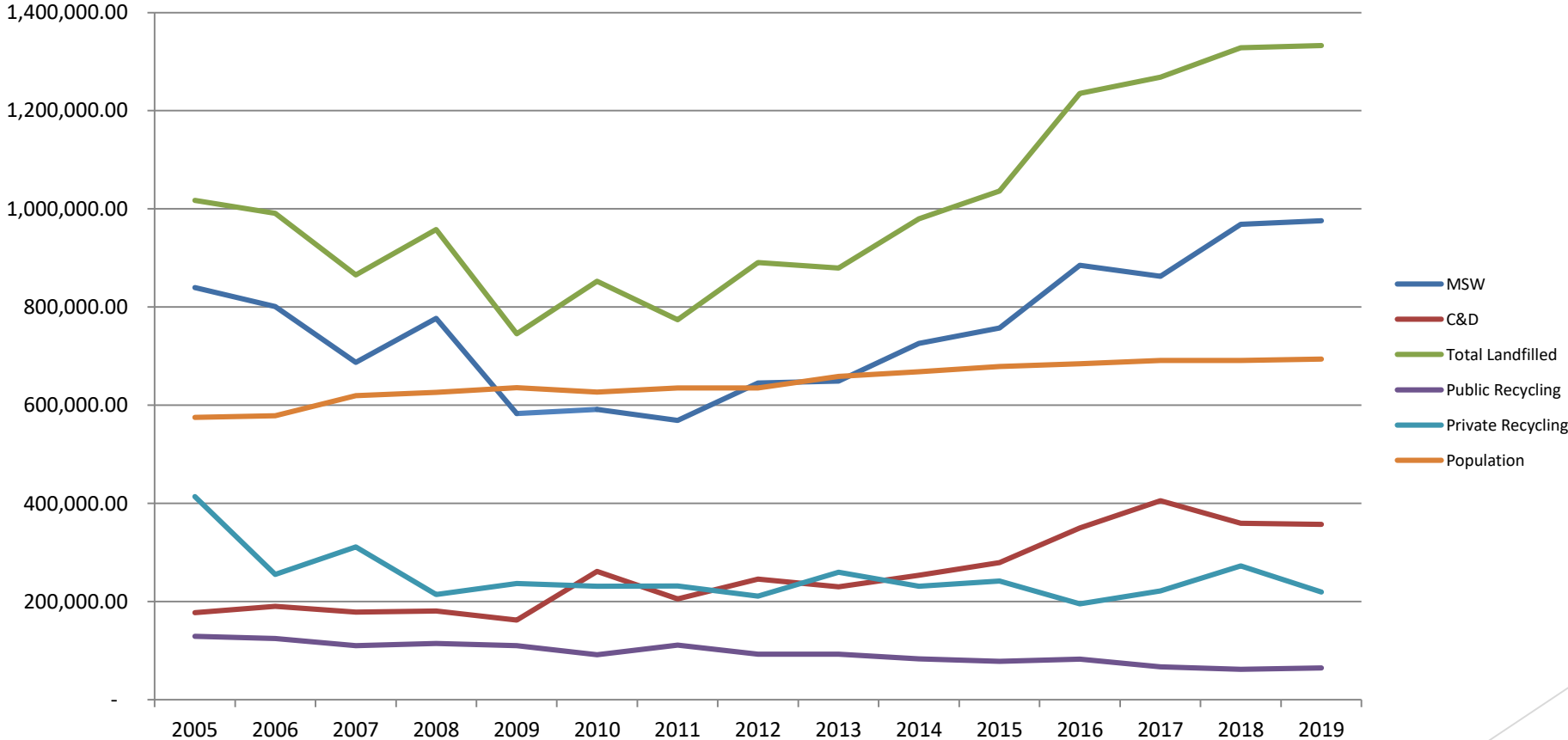
