New Horizons Solutions

Strengths

Proposal demonstrated firm's proposed SLP(s) experience, organizational skills, and ability to work well with children. Proposal demonstrated firm's willingness to accommodate Metro's time for providing services. Proposal provide proof of ASHA certification for proposed SLP(s). Proposal demonstrated firm's understanding of Metro's procedures and protocol for providing services. Proposal demonstrated firm's proposed SLP(s) ability to provide a quick turn-a-round on services and providing reports. Firm's proposal demonstrated and provided all other required information with the exception of the weaknesses noted below.

Weaknesses

Proposal failed to demonstrate and/or confirm qualifications and certifications for proposed SLPA staff. The use of SLPA(s) is not acceptable to Metro. Firm's provided reference projects were not of similar size, scope, and complexity to scope of work in this RFQ. Proposal demonstrated firm has limited experience in providing scope of work in this RFQ. Firm's proposed project approach failed to address plan for providing multi-lingual services, was instructional to Metro rather than informational for Metro, and lacked detail on firm's overall approach for providing services per the scope of work in this RFQ.
