**Weakness** - Failed to provide a response to contracts awarded with Metro. Company's Plan for receiving calls, scheduling and dispatch capability and methodologies to ensure proper handling of moving services lacked specific detail. Response to approach to managing the project expertly and efficiently was generic and lacked specific detail. Organizational chart of company lacked specific detail. Failed to provide resumes. Response to company having the staff with the skills and certifications necessary to perform the services required lacked detail. Response to company's ability to handle number of moves at given time and ability to comply with the needed response times lacked detail.

**Strengths**- Detailed work experience. Detailed Firm's adequate machinery and equipment to perform the work. Firm's general qualifications and background was adequate.

**Weakness** - Failed to provide projects of similar scope. Company's Plan for receiving calls, scheduling and dispatch capability lacked specific detail. Methodologies to ensure proper handling of moving services and proposed approach to managing the project expertly and efficiently lacked detail. Failed to list number of employees. Failed to provide organizational chart of company. Failed to provide resumes. Response to company having the staff with the skills and certifications necessary to perform the services required lacked detail. Response to company's ability to handle number of moves at given time and ability to comply with the needed response times lacked detail.
