- Any of the owners, partners, officers, directors, or members has violated any portion of this chapter of the Metropolitan Code within five years immediately preceding the date of application.
- Any portion of the application is incomplete or contains incorrect or untruthful information.
- An applicant will be ineligible for consideration for a one-year period if any owner, partner, officer, director, or member has been found guilty by a court of competent jurisdiction of violating state law or Metropolitan Code provisions three or more times within the past 365 days pertaining to noise from motor vehicles, lewd conduct as part of a commercial business, and/or alcoholic beverage open containers.
