
Speedway Activation

Under the proposed lease agreement, there is no fixed limit on the number of Motorsports Events (events in which Race Cars compete on the track), practices, or music events that can be held in a year. But as a practical matter the number of Motorsports Events is constrained by limiting the number of weekends on which Motorsports Events can occur to 10 per year unless the Fair Board approves more. Track practices, except for practices on NASCAR Cup Race days, are similarly constrained to 20 weekdays per year and must be scheduled only between 3:00 PM and 7:00 PM on any day. (In the event a practice is delayed for more than 20 minutes by weather or emergencies, the curfew may be extended to 7:30 PM). Mufflers must be used for all Motorsports Events and practices other than NASCAR Cup Races and associated practices. Motorsports Events, other than NASCAR Cup races, must be scheduled within the following limits and must end by 11:00 PM even in the case of race delays:



Bristol is required to use best efforts to schedule NASCAR Cup Races within the same time limits. A NASCAR Cup Race or practice could but is unlikely to occur on a weekday. Sound amplification, such as for concerts, must end by 10:00 PM on any day.

A sample calendar showing the times when amplified sound (—) and races (—) or practices (—), other than NASCAR Cup Races and practices, could be scheduled under the lease is as follows:

Bristol projects the following events for typical years in which NASCAR Cup Races do and do not occur. The CSL report is based on the same events (with one fewer music event) but estimates lower attendance figures for some.
