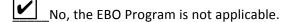

Evaluation Comments

The Andersons, Inc.

Strengths

Proposal demonstrated extensive experience in providing similar products. Demonstrated strong supply chain capabilities through diversified suppliers of materials and multiple facilities capable of producing multiple products. Proposal detailed multiple fleets to be utilized in delivery of product. Outlined numerous staff with 24 hour support. Subject Matter Expert has extensive industry experience and is available for multiple types of consultation including on-site and application system review. Reference projects for Clayton County Water Authority and Stickney WWTP were of very similar size and scope. Product references were specific to application of Class A biosolids at application rates of less than 2 gallons per ton.

Weaknesses

One of references submitted was not of similar size and scope as requested. Methodology of business was not clearly defined and described some processes generically.

Momar, Inc Strengths

Proposal demonstrated strong supply chain capabilities through diversified suppliers of materials and multiple facilities capable of producing multiple products. Described mulitple delivery resources. Outlined a strong communication methodology. Desribed a thorough Quality Control process, including pre-inspection, delivery review, courtesy calls for deliveries, and having a staff member present for first 3 deliveries. Subject Matter Expert listed has extensive industry experience.

Weaknesses

Offeror did not provide references of use for DustNot TOP Class A or Class B. Offeror provided references for Glycol-based oils, none of which demonstrated use in tall oil or Class A applications. Proposal did not clearly outline how Subject Matter Expert would assist in optimizing MWS process or products. Expereince desrcibed in tall oils was in agriculture, not Class A applications. Flash Point for DustNot did not meet listed product specifications requested.
