Provided firm's ability to work as a team with Metro staff. Provided comparison tools & sample size used to compare Metro's Pension Plan to other pension plans of a similar size. Detailed client data and security initiativesmeasures implemented to safeguard data and accounts information. Provided ability to meet Metro's travel schedule to complete work and meet the requirements.

#### Mooknosso

Did not provide Workchart. Lack of Information related to team members past performances on similar projects. Past and current team member's experience not of equal size and scope of Metro. DEI information and plan of action lacked details and content. Work Plan lackedd details related to staffing, communication, and quality control. Vague information on how the provisions of the scope of work will be implemented. Lack of detail related to team's roject approach and ability to work as a team with Metro staff. Lack of information regarding assessing risks, challenges, and/or concerns the firm may have with performing referenced work. Did not provide a description of research department or how reearch is conducted for the firm. Firm provided no Public Plan references or experience. Vague information on how firm's strategy om developing a strategic asset allocation strategy disciplined rebalancing, and tactical asset allocation changes. Did not provide firm's knowledge of similar project. Lack of experience on similar projects. Didn't detail responsibilities for key team members. Details concerning previous project experience on included. Specimen Report lacked information and content related to Scope of Work. No previous projects of a similar size, scope, or complexity of Metro referenced in proposal. Lack of nformation on experience reviewing investments and investment performance.

Provided comparison tools & sample size used to compare Metro's Pension Plan to other pension plans of a similar size. Detailed client data and security initiativesmeasures implemented to safeguard data and accounts information. Project Timeline meets Metro's need.
