# **1,687 people** experiencing homelessness were housed in Nashville from May 2022 through April 2023. This is a **15% decrease** from last year (May 2021 through April 2022.)








- 61% of the people who moved from homelessness into permanent housing in April are Black.
- 30 people exited to permanent housing with a Housing Choice Voucher in April. That is the highest number since this report began.
- Our community continues to house fewer people each month than the previous 12 month period. The 15% decrease for this 12-month period represents 306 fewer people being housed.

## **Street Outreach**



**Street Outreach (SO)** projects offer services necessary to reach out to people experiencing unsheltered homelessness, connect them to emergency shelters, housing, or other services, and provide urgent non-facility-based care to people unwilling or unable to access emergency shelter or other housing.

- 18 clients (1.2%) exited Street Outreach programs to permanent housing destinations in April.

- The completeness of this data has fluctuated based on agency participation.

-O- # of People Per Month Exiting SO Programs to permanent destinations


## **Emergency Shelters**

**Emergency Shelter (ES)** projects offer temporary shelter/lodging for people experiencing homelessness in general or specific populations of people experiencing homelessness.

HMIS-Participating ES Providers:



- 8 agencies provided Emergency Shelter bed services to 304 clients (198 households) in April.
- 50 člients (16.4%) exited Emergency Shelter programs to positive housing destinations in April.
- 1,710 unique clients have been served by Emergency Shelter projects since May 2022.

# **Transitional Housing**



**Transitional Housing (TH)** projects provide individuals and families experiencing homelessness with the interim stability and support needed to successfully move to and maintain permanent housing.

#### HMIS-Participating TH Providers:



- 7 agencies provided Transitional Housing services to 219 clients (185 households) in April . This data does not include the Nashville Rescue Mission.
- 27 clients (12.3%) exited Transitional Housing programs to positive housing destinations in April.
- 527 unique clients have been served by Transitional Housing programs since May 2022.

# **Rapid Rehousing**

**Rapid Rehousing (RRH)** projects fund short-or medium-term rental assistance and housing relocation/stabilization services designed to quickly move individuals and families from emergency shelters or places not meant for habitation into permanent housing.



- 10 agencies provided Rapid Rehousing services to 1,449 clients (640 households) in April.
- 852 of those people (394 households) have moved into housing so far.
- 107 clients exited Rapid Rehousing programs to positive housing destinations in April.
- 22 clients exited Rapid Rehousing programs to homelessness, institutions, or death in April.
- 2,491 unique clients have been served by Rapid Rehousing programs since May 2022.

# **Permanent Housing**




**Permanent Housing (PH)** projects are community-based housing without a designated length of stay in which formerly homeless individuals and families live as independently as possible. Under PH, a program participant must be the tenant on a lease for an initial term that is renewable. Permanent Supportive Housing (PSH) projects are projects that offer permanent housing and supportive services to assist homeless persons with a disability to live independently.


