








Housing Exits by Destination

Street Outreach



Street Outreach (SO) projects offer services necessary to reach out to people experiencing unsheltered homelessness, connect them to emergency shelters, housing, or other services, and provide urgent non-facility-based care to people unwilling or unable to access emergency shelter or other housing.



-O- # of People Per Month Exiting SO Programs to permanent destinations


Emergency Shelters

Emergency Shelter (ES) projects offer temporary shelter/lodging for people experiencing homelessness in general or specific populations of people experiencing homelessness.

HMIS-Participating ES Providers:



- 8 agencies provided Emergency Shelter bed services to 646 clients (463 households) in November.
- 9 clients (1.4%) exited Emergency Shelter programs to positive housing destinations in November.
- 1,440 unique clients have been served by Emergency Shelter projects since December 2021.

Transitional Housing




Transitional Housing (TH) projects provide individuals and families experiencing homelessness with the interim stability and support needed to successfully move to and maintain permanent housing.

HMIS-Participating TH Providers:



- 8 agencies provided Transitional Housing services to 217 clients (181 households) in **November**. This data does not include the Nashville Rescue Mission.
- 21 clients (9.7%) exited Transitional Housing programs to positive housing destinations in November.
- 469 unique clients have been served by Transitional Housing programs since December 2021.

Rapid Rehousing

Rapid Rehousing (RRH) projects fund short-or medium-term rental assistance and housing relocation/stabilization services designed to quickly move individuals and families from emergency shelters or places not meant for habitation into permanent housing.



- 11 agencies provided Rapid Rehousing services to 1,569 clients (737 households) in November.
- 852 of those people (420 households) have moved into housing so far.
- 28 clients exited Rapid Rehousing programs to positive housing destinations in November.
- 13 clients exited Rapid Rehousing programs to homelessness, institutions, or death in November.
- 2,395 unique clients have been served by Rapid Rehousing programs since December 2021.

Permanent Housing



Permanent Housing (PH) projects are community-based housing without a designated length of stay in which formerly homeless individuals and families live as independently as possible. Under PH, a program participant must be the tenant on a lease for an initial term that is renewable. Permanent Supportive Housing (PSH) projects are projects that offer permanent housing and supportive services to assist homeless persons with a disability to live independently.


Homelessness Prevention
