It should be a calm residential street but it is a harrowing, stressful trek for pedestrians who don't have a choice as there is not an easy alternative nearby parallel street. Some kind of walking zone would provide safe access for all.

3 An initiative where residents who are struggling to pay bills can provide some benefit to the community and receive assistance with their bills. We are seeing many posts in NextDoor and Facebook groups from individuals and families who struggle to pay electric bills, grocery bills, etc. Can there be some kind of financial assistance people can receive in exchange for doing volunteer work that the city/neighborhoods benefit from? Maintaining public areas, picking up trash, etc.

4 Senior citizen community-building. So many of our residents are elderly and living alone, and are starting to lose the ability to drive themselves. Some residents have been told they shouldn't go outside and wander their yards in case they fall and are unable to get up/call for



help. Can we organize a bus service once a week/month, that drives around Inglewood and picks them up and takes them on a field trip? It can be to a state park where they bring their own lunch and just get to eat outdoors. The trip could be to a local attraction and there could be a mini walking tour, or to a movie theater. Perhaps the budget could go to an existing organization with experience in this kind of programming/organization.

Locals or long-time transplants may remember a time in the early 2000s when colorful catfish dotted the Nashville landscape. Miss Finnie Pearl and Spider Cat were two of the Catfish Out of Water art pieces, a project involved the creation and installation of a series of 7 foot long fiberglass catfish sculptures throughout the city. Each catfish sculpture was uniquely designed and decorated by local artists, reflecting their individual artistic styles and interpretations. Nashvillians and tourists alike embarked on a citywide scavenger hunt to discover and appreciate each unique catfish artwork. The project brought people together, sparked conversations, and generated a renewed appreciation for public art and the city's cultural heritage.

The 2003 project was sponsored by Patrons and Greenways for Nashville, Cumberland River Compact, Parthenon Patrons and Greenways for Nashville to raise awareness about Cumberland River water quality. 20 years and an "it-city" boom later, it's again time we decorate Nashville street corners and gathering places with new art pieces that teach and delight.

I propose Nashville invest in a city-wide art project aimed at raising awareness for a chosen topic, celebrating local artists, and generating excitement/economic growth for locals and visitors.

As someone born and raised in the area, several ideas come to mind for topics of the project and templates for the to-be-designed sculptures. Perhaps an aspect of this project is that the focus is also chosen by residents or this budgetary committee. Some suggestions:

1. **MUSIC NOTES:** As Music City, this option encompasses a large portion of what Nashville has to offer. Consider the vast amounts of non-profits/orgs that focus on music education for youth, underserved communities, etc. Music notes would be easy to pose with for photos for those who want to "collect" each sculpture.
2. **HONEY BEES:** Agriculture is Tennessee's largest industry, and the official state insect has a large contribution to that effort. Honey bees are vital in pollination for crops, trees, and grasses. With the bee population in decline, imagine the support we can give this cause with this project.
3. **TRI-STAR:** As Nashville grows in the national spotlight, so too does the symbolism and love for the tri-star. I would love to see the different themes used by artists to emblazon our stars



and the circle field behind it. With homelessness on the rise in the area, perhaps this focus can show we care for everyone under the tri-star flag, with financial support going towards supporting this population.

4. TOMATOES: The tomato was designated the state fruit the same year as the catfish art project. Maybe tomatoes can be the chosen focus and be tied into the Tomato Art Fest.

5. DOLLY: Dolly does no wrong. Maybe we can't put up 50 busts of the patron saint of Tennessee but we totally could, but there could be another connection - butterflies, books? One objection you may have is, "We have tons of murals!" You'd be right. I'm a fan of what large art pieces like that do for our city's landscape. So what's the difference?

A. FEASIBILITY: Not everyone can source a blank wall and the materials to paint a mural - but people of all kinds can paint a fiberglass sculpture. Which undiscovered artists are lurking in our city, waiting for an opportunity such as this?

B. TRANSPORTABLE: A fun 2015 Reddit thread asked, "Where are the Nashville catfish sculptures now?" Inevitably, a project like this runs its course. Murals are painted over, but these art pieces can live forever in corners of bars, eccentric backyards, and antique stores.

C. UNIFICATION: It's easy to visit the multitude of murals in our city, but one thing they lack is a unified effort. Each mural has it's own focus - often it's to generate visitors to a business. The celebration of this art project can be as amplified as we want - a scavenger hunt, a festival, an educational tour; whatever the focus, the guiding committee would have full control.

The benefits of a new city-wide art project are multifaceted:

1. **EDUCATION:** The chosen focus of the project will be broadcast to the residents of and visitors to the nation's 21st largest city. Whether it's honey bees or literacy, the word will be spread in a tangible, visible, memorable way.
2. **PUBLIC WELLNESS:** Studies show that public art has a host of mental health benefits for residents. Its community-building powers can combat feelings of anxiety and social isolation. When locals participate in creating public art, these effects are amplified. A 2018 London-based survey found that 84% of respondents believed participating in public art projects benefited their well-being. 3. **COMMUNITY RELATIONS:** Art projects bolster community relations. In the 2003 catfish project, local businesses adopted the fish and even bid on the finalists submissions that didn't get "catfish-ified". I remember because I was one of them! At 13 years old, I submitted 3 ideas. 2 were chosen to be finalists, and although I didn't end up getting to paint a catfish of my own, the art submissions were purchased by businesses downtown who displayed them.
4. **ECONOMIC BOOST:** It's estimated that 14.4 million people visited Nashville in 2022, according to VisitMusicCity.com. With that many eyes on the Music City, imagine how a well-crafted art project will inspire visitors and locals alike to "collect" photos at each statue. In a world when social media photos tell 10 different stories at once, Nashville can capitalize on the love of our city by weaving tourism and education/awareness together.
