V. Background: There are significant safety concerns for motorists entering and exiting the 3 Mill Ridge Park properties along Old Hickory Blvd, especially at the Community Farm and Friends House entrances, due to multiple risk factors. Key risk factors include unexpected driveway appearances, poor access management, and roadway geometry and visibility. There is high travel volume and speed in the area, as it is a significant transit route with adjacent properties with a variety of uses. There are 2 lanes. The road is highly curved, hampering visibility. The driveways for the Friends House and the Community Farm, unpaved and situated in seemingly undeveloped parcels and moderately to heavily flanked by trees, emerge suddenly for motorists. This could lead to abrupt braking, which would occur directly on the travel lanes. There are no turning lanes present and access management is poor. Both properties lack permanent signage. The greatest hazard is to motorists attempting to exit those 2 properties, due to low to non-existent visibility of oncoming traffic.

VI. Proposed Solution:

Strategically installed flashing caution signs would act as conspicuous markers to prealert the motorists traveling down OHB to expect turning vehicles and driveways. Benefits are: 1. Enhanced visibility 2. Speed moderation 3. Reduced Collision Risk. Additionally, Mill





Ridge Park is a high profile development and is expected to receive heavy use. The plan is for the park to encompass properties on both sides of OHB. These risks are critical to address.

VII. Next steps: Post acceptance, Department to finalize design, procurement, and installation details.

VIII. Timeline: Estimated completion is 12-36 months from approval, subject to city processes and procurement times

- V . Background: Mill Ridge Park is a newly-established Regional large acreage anchor park serving southeastern Davidson County and the highly diverse Antioch area. The Park's Master Plan incorporates a variety of features designed to be accessible to residents of different ages, cultures, socio-economic backgrounds, abilities, and interests in the area. The Master Plan specifies the locations of the community garden and the opportunities community gardening provides for social and community connections, in addition to growing food. There is strong community interest in using the gardens, and a number of potential area partners. The garden will follow the productive gardens framework. Water access is crucial. A water tie-in involves connecting the park to Metro Nashville's existing water infrastructure. While detailed technical planning requires expert intervention, preliminary assessments suggest a connection to the nearest mainline, equipped with appropriate metering and distribution points within the area. There is a planned 10 x 20 shed that could potentially house the meter. In addition, the Park's effort to obtain water by digging a well did not succeed. It was assessed that it would be more financially sustainable for the park and the community organizations utilizing the space to pay the city for water over the long term

VI. Next steps: Post acceptance, Department to conduct technical assessment, finalize design and plan, construct tie-in, and carry out quality assurance

VIII. Timeline: Estimated completion is 6-12 months from approval, subject to city processes and complexity of the project

#### **Short Description:**

Purchasing a parcel of land that forms a keystone sitting directly in the center of approximately 350 acres of "protected" woodlands. This land is at risk of development and destruction. Purchasing this land would allow for the expansion of the West Meade Waterfall Park, allow protection of the large old-growth trees that sequester maximal carbon, allow for continuity of the Highland Rim Corridor that links all of Metro's Grand Parks, provide a secure wildlife corridor and protect the steep slopes of West Meade.

### **Long Description:**

Sitting just above and adjacent to The West Meade Waterfall Metro Pocket Park are 19.5 acres of privately owned old-growth forest in the midst of Nashville's Highland Rim Forest. The property is breathtaking with some of the largest trees that still exist in Nashville. Ephemeral wildflowers bloom in the spring, carpeting the forest floor. Snags and rotting logs there since the founding of Nashville still feed life. There is wildlife galore. This land holds the headwaters of Richland Creek. The parcel forms a keystone sitting directly in the center of approximately 350 acres of "protected" woodlands. (These woodlands are protected by SP zoning and include the Highlands property and Nandi Hills). This 19.5 acres is at risk of development and destruction.

In this instance, because the Participatory Budgeting funds need to be distributed with some expediency, our proposal will include the following provisions:

- 1. In my estimation, a fair offer to Mr. Leonard for the 0 Jocelyn Hollow Property is \$800,000. Fifty percent of that figure would come from the Participatory Budgeting Process and we would make every attempt to raise the additional \$400,000 within the community and from the various agencies we partner with.
- 2. In the interim, during fundraising and negotiating a sale with Mr. Leonard, the 501C3, Radnor to River, (Dr. Noah Charney, Executive Director) has agreed to hold the funds distributed from Participatory Budgeting until such sale ensues.
- 3. Should Mr. Leonard reject our purchase offer or should we be unable to raise sufficient funds to purchase 0 Jocelyn Hollow within a reasonable time period, the Participatory Budgeting funds will be returned to Metro.
- 4. A timeframe should be discussed and implemented to make sure that if this cannot happen the money will revert to Metro to be spent per the PB and ARP guidelines and deadline.





• Staff has discussed this proposal and while it appears to have high conservation value, we would not be able to support the acquisition at this time. The narrative illustrates that the land is not under development pressure due to lack of access to the property, along with the existing steep slopes which would limit developable area. Currently since the only access to the property for Parks would be by foot from the Belle Meade waterfall site on Hathaway Court, maintenance and security would be a challenge. Until the site can be accessed from another location, there would be no public parking and limited public access. The adjacent residents on Hathaway Court where the waterfall property is located, have complained about the public parking on their dead-end street and interfering with access to their private homes while accessing the waterfall. There is no assurance that the seller would reduce the asking price by more than half, and the city would not give Metro Dollars to a non-profit to hold.

#### **Long Description:**

This project has two components that would enhance the streetscape and enrich the neighborhood. First, place historic markers throughout the Belmont-12South neighborhoods to tell the story of the neighborhood's black history, including Bass Street Neighborhood, Nashville's first post-emancipation black neighborhood; the former home of the Rev. Kelly Miller Smith; the Rose Hill development; and 12South African American businesses. "This history has largely been erased in the development of the neighborhood, and many current residents are unaware of it. Second, the project would enhance the neighborhood by placing benches along Blair Boulevard and Natchez Trace, two heavily used pedestrian corridors, the benches would be of particular importance to aging adults and those with disabilities.

- The submission suggested four locations for historical markers, however, we would suggest adding two additional locations for a total of six. The additional markers will allow us to tell a more complete history of the Belmont-12 South neighborhoods by including additional African American businesses. The approximate cost of a historical marker is \$4,000, and \$24,000 will provide funding for six markers.
