XIV. REPORT OF THE DIRECTOR

- Encouraged Board members to explore some of the many activities and special events occurring throughout the parks system this month.
- Staff is continuing to work to fulfill FY24 budget investment request, which include positions and operation improvements.
- Warner and Shelby Park Nature Centers have developed a five-hour professional development course, which offers a certification; free of charge for teachers focusing on science investigation.
- Beaman Nature Center is working on environmental science partnerships with area universities, working on watershed mapping and ecosystem analysis.
- A facilities condition assessment has been procured for the buildings in our parks system, to measure the physical condition and functional performances of the buildings infrastructure. The assessment is to determine whether our buildings are suitable and appropriate for their intended functions. Improvement priorities will commence based on timeline and cost. The assessment for the first twenty-six of fifty-two buildings should be completed by the end of October.
- Happy to announce that our disAbilities program will be expanding to two new satellite locations, Madison Community Center and Cleveland Community Center. Over the last four years the disAbilities Program has expanded beyond the headquarters of the Sportsplex to Coleman Community Center and Bellevue Community Center.
- Community Centers and Cultural Arts are very busy with after school programing.
- Cleveland Community Center grand reopening is now scheduled for September 23^{rd.}
