We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met.

- 2. Darrell Hardrick Sr., Metro Beer Permit Inspector III

Andrew St. Marie plead guilty with an explanation for both trials, #31 and #32.

Inspector Hardrick read the reports from both incidents that occurred during the Under 21 compliance checks. He also informed the Board that the permit holders did sign up for the training offered by our office and completed that training. A follow-up inspection was conducted after the training was completed and the location did pass the inspection. Andrew St. Marie informed the board that additional signage was put in place that says "Must be born on or before this date", which must be updated daily.

Following a brief discussion, Ms. Jarmon made a motion to issue a \$4,500 civil penalty or the option to serve a 21-day suspension, followed by a 120-day probation period. Ms. Fox seconded the motion. The motion was unanimously approved.

The following individuals were sworn-in to testify in this hearing:

- 1. Lucas Watson, Co-Owner of The Silo Market
- 2. Andrew Watson, Co-Owner of The Silo Market
- 3. Darrell Hardrick Sr., Metro Beer Permit Inspector III

Mr. Watson plead guilty with an explanation.

Inspector Hardrick read the report from the incident that occurred during this Under 21 compliance check.

Mr. Watson informed the Board that they have implemented the following:

- 1. Conducted 1 on 1 training with staff internally
- 2. Let the employee go after determining that his story was false by watching the recorded video of events that transpired.
- 3. Did reach out to the Inspector afterwards to personally apologize for the way his employee handled himself.
- 4. Put up additional signage at the point of sale (POS)

Mr. Watson asked that the Board give some leniency in punishment due to them being a small business. Inspector Hardrick provided some additional testimony.

He informed the Board of the following:

- 1. He provided a brief personal background of the co-operating minor.
- 2. The clerk that made the sale accused the minor of using a fake ID.
- 3. The clerk then proceeded to lay on the ground kicking and screaming.
- 4. Inspectors, realizing the subject may be in the midst of a mental illness crisis, quickly deescalated the situation without an incident.
- 5. The location did pass the follow-up inspection

Ms. Perry asked the permit holder what, if any, remediation was put in place. Mr. Watson informed Ms. Perry and the Board that the following remediation was put into place:

- 1. Put up additional signage at the POS
- 2. Conducted 1 on 1 training in-house

Ms. Jarmon made a comment regarding having another conversation about the safety of the Beer Board Inspectors after hearing this testimony. She then asked the Board if it was possible to issue a \$1,500 civil penalty and if they were to sign-up for our training, could we apply \$500 of that payment to the training.

There was some brief discussion on this question.

Ms. Glapion asked the Board if the civil penalty could be paid in segments. Metro Attorney, Matthew Garth, informed the Board the payment must be paid in full within the seven (7) calendar days allowed.

After this discussion, Mr. Watson informed the Board that he wasn't aware that we offered any training.

Ms. Fox made a motion to issue a \$1,500 civil penalty or the option to serve a 7-day suspension, followed by a 14-day probation period. Ms. Glapion seconded the motion. Brian voted against this motion. The motion failed.

Ms. Glapion made a motion to issue a \$750 civil penalty or the option to serve a 3-day suspension, followed by a 30-day probation period. The motion was not seconded. The motion failed.

Ms. Perry made a motion to issue a \$750 civil penalty or the option to serve a 5-day suspension, followed by a 30-day probation period. Ms. Jarmon seconded the motion. The motion was unanimously approved.

(34) ADMINISTRATIVE

Ms. Jarmon suggested scheduling a special called meeting with Metro Legal to discuss Inspector safety. She also requested that Beer Board Staff/Director reach out to peer city and/or other state agencies that may have some additional insight on improving inspector safety come to one of our board meetings to speak with the Board on these matters.

Director McDonough said he thinks that is a great idea, but would likely take some time to put together. He also pointed out that most other cities in Tennessee use police officers to enforce the beer laws and that we typically lead the state in matters related to Beer Boards.

Inspectors Hardrick and Brown spoke to the Board as well regarding safety of Inspectors.

No official business occurred relating to this subject tonight.

(35) EXECUTIVE DIRECTORS REPORT

Director, Benton McDonough, provided the revenue-to-date report to the Board. The Board didn't have any question/concerns.
