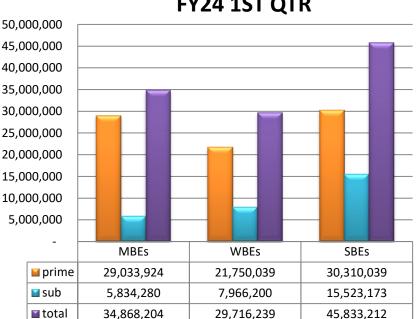

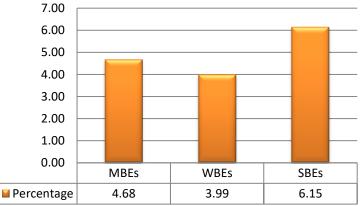


Business Utilization (\$) FY24 1ST QTR

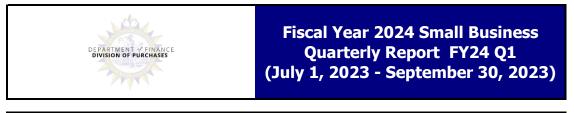
