## Graph 1

This chart presents information about board membership. There are currently 70 active board members, with complete information available for 26 boards and incomplete information for 44 boards. Among the 636 total board seats, 573 are occupied while 63 are unoccupied. Furthermore, there are 665 pending membership applications, with 471 recently submitted and 194 submitted more than six months ago.

This graph present data on the Sexual Orientation preferences among both members and applicants. For members $1 \%$ identify as bisexual, $94 \%$ do not identify, $5 \%$ identify as gay, and $<1 \%$ identify as queer. For applicants, 2\% identify as bisexual, $89 \%$ do not identify, $3 \%$ identify as gay, $3 \%$ identify as lesbian, $2 \%$ identify as queer, and $1 \%$ identify as transgender.

This graph presents data on LGBTQ+. For Members 6\% prefer not to say, $90 \%$ do not wish to identify as LGBTQ+, and 4\% openly identify as LGBTQ+. For Applicants 7\% prefer not to say, $85 \%$ do not wish to identify as LGBTQ+, and 8\% openly identify as LGBTQ+.

Data on Ethnicity show among members, 6\% identify as Hispanic, Latino, or of Spanish origin, 4\% prefer not to say, and 90\% do not identify as Hispanic, Latino, or of Spanish origin. For applicants, 4\% identify as Hispanic, Latino, or of Spanish origin, $5 \%$ prefer not to say, and $91 \%$ do not identify as Hispanic, Latino, or of Spanish origin.

Data on Gender status show among members $50 \%$ identify as female and $50 \%$ identify as male. For applicants, $42 \%$ identify as female, $54 \%$ identify as male, $1 \%$ identify as nonbinary, $2 \%$ prefer not to say, and $1 \%$ identify as transgender.


This graph presents data on years of service on the Metro Boards and Commission. For members $21 \%$ served 1-2 years, 17\% 2-3 years, $10 \% 3-4$ years, $9 \% 4-5$ years, $43 \% 5+$ years. For applicants $25 \%$ served 1-2 years, $17 \% ~ 2-3$ years, $10 \% 3-4$ years, $8 \% 4-5$ years, $40 \% 5+$ years.

This graph presents data on Race Group. For members 1\% American Indian, 3\% Asian, 31\% Black or African American, 5\% Hispanic or Latino, < 1\% Native Hawaiian or Pacific Islander, 60\% White.
