The permit application will be assigned to a zoning examiner. Should the Zoning Examiner have any questions or need additional information they will reach out to you by e-mail or by phone.

Once your application is processed, a Zoning Examiner will provide a checklist showing other Codes divisions and Metro agencies to contact for approvals before the permit can be issued. It is your responsibility to follow the requirements of the checklist on the building permit application and to make sure all necessary signoffs are received. Do not seek to determine what reviews and approvals are required on your own. If you fail to complete the steps identified in your permit application your process will be delayed. Allow plenty of time. You can track the progress of the application by address or by using the permit application number at https://epermits.nashville.gov/#/

Once you have all the required signoffs you can pay for the permit and begin construction. It is also the applicant's responsibility to schedule the necessary inspections with Metro Nashville at the proper time in the building process.

#### SELF BUILDING PERMIT RESPONSIBILITY

I hereby acknowledge that I am applying for this **SELF BUILDING PERMIT** in my own name, as property owner or lessee and I will act as my own general contractor accepting full responsibility for code compliance, for hiring and employing individuals, and subcontractors with ultimate responsibility for my own work and for the work of others. Acting as my own general contractor, **I further understand that I may forfeit certain protections,** which might be available to me through the State of Tennessee general contractor's licensing process. I further acknowledge that as a **SELF BUILDING PERMIT** holder I am responsible for requesting all required inspections and completing all authorized work in compliance with applicable adopted codes. **I further understand that separate permits are required for any proposed <u>electrical.</u> <u>plumbing, and gas/mechanical</u> work and is not part of the building permit.**

#### SELF PERMIT AFFIDAVIT

When a contractor obtains a building permit, the firm or corporation is totally responsible for the total construction including subcontractors to meet all codes. If the construction fails to comply with all codes, their bond of \$10,000.00 or \$40,000.00 can be used to repair the code violation.

When an owner obtains a building permit, he or she is totally responsible for the code compliance of the total construction project including subcontractors, even if a contractor is hired and the construction does not comply with all codes.

#### In effect THE OWNER. BY TAKING OUT THE PERMIT. THE \$10.000.00 OR

## <u>\$40.000.00 BOND PROTECTION IS LOST.</u> The only recourse left is to sue the contractor is Civil Court.

*For contractor bids under \$25,000.00 but over \$3,000.00*, a person or firm who gives bids to a homeowner is required to be registered by the State as a Home Improvement Contractor or a Residential State Contractor.

*For contractor bids of \$25,000.00 or greater*, a person or firm who gives bids to an owner is required to be a State Licensed Contractor.

For accepting a bid of \$25,000.00 or greater, a person or firm who accepts a bid from an unlicensed contractor is guilty of a Class A misdemeanor. A Class A misdemeanor penalty is 11 months & 29 days in jail.

#### SELF PERMIT AFFIDAVIT


