Discussion and approval of FY24-25 Budget

As the Commission reviewed both Operating and Administrative (Election) Budgets as presented, AOE Roberts reported the Operating Budget includes an additional \$35,300 for postage/printing of voter registration cards, resulting from the population growth in Davidson County.

Commissioner Herzfeld inquired about increasing the number of staff. AOE Roberts informed the Commission of vacant funded positions being evaluated to ensure the office is sufficiently staffed. Commissioner Starling inquired about increasing the pay for Poll Officials. AOE Roberts informed the Commission there is a pay increase included in the budget for the fiscal year beginning in July.

Commissioner Herzfeld inquired about the move of the Election Commission main office now that the Genesco building has been demolished. AOE Roberts informed the Commission that he would reach out to the Administration and inquire about the planned move. He will report the response from the Administration to the Commission at a future meeting.
