# Director's Update to the Board of Health March, 2024

#### Protecting Health - Preventing the Spread of Infectious Disease

#### Winter maladies (and measles)

COVID-19, Flu, and RSV numbers continue to fall nationally and here in Davidson County.

We have not seen any cases of measles in Tennessee but about two dozen cases have been reported across the country since the beginning of the year.

#### **PrEP Clinic Update**

Based on data comparing January and February of 2023 to those same months this year, the PrEP clinic has increased the number of patients seen by 29.3 percent. Since the start of 2024 we have received 37 referrals. Of those, 28 have been added to our patient load. This is the current count as of March 11. We also have observed a 16.6 percent increase in the number of women who started on PrEP since October 2023. Every year, we set a goal for our clinic with the State Department of Health to increase our numbers of new patients. In 2023, our goal was to add 60 new patients to our clinic. We met and exceeded this goal by adding 63 patients in 2023.

One initiative we have been working on is getting more patients on Apretude, the long-acting injectable PrEP. Since October, we have successfully approved four patients, bringing the total to six. We have four applications awaiting approval. Additionally, we are establishing a partnership with VIIV to facilitate the approval process for both uninsured and insured patients.

We also have implemented rapid HIV testing at patient appointments, allowing us to initiate them on oral PrEP on the same day. The majority of our patients leave with a starter pack of Descovy. We have successfully collaborated with our partners at Gilead to ensure we have starter packs and printed medication information for our patients when they leave their first visit.

Due to the recent rise in syphilis cases among women, we are working on a marketing strategy to get more women on PrEP. We are still in the planning stages with the communications team, but we hope to add more female patients to our case load in 2024.

We have reviewed responses to the RFP for a pilot treatment program for opioid response and are in process on awarding the successful applicant(s). We will need to take these through Metro council for approval to spend opioid settlement monies.

#### **Improving Access to Healthcare**

#### **Covid Vaccination Campaign**

Over the winter months when respiratory infections commonly circulate, MPHD carried out a successful targeted media campaign to encourage COVID-19 vaccination. The campaign was focused on geo-targeted areas that are served by the COVID Disparities Grant, prioritizing those whose health needs are underserved. Videos and still images in English, Spanish and Arabic were created to inform audiences about the new, widely available COVID-19 booster. The campaign ran from November 10 through January 31, performing at or above baseline expectations in all placements. More than 884,000 total impressions were recorded across display, pre-roll ads for video clips, and connected TV placements.

#### **Baby Shower**

The Nashville Strong Babies program conducted another successful Community Baby Shower, an annual event where families can learn about services and resources available in the community. More than 200

families pre-registered for the event at the Cal Turner Family Center on the Meharry Medical College campus. Prizes were awarded and families were able to speak with medical students about their baby's health concerns. Immunizations were available for attendees. In addition to the Nashville Strong Babies program, the Breast and Cervical Cancer Screening, Family Planning and Ending the HIV Epidemic programs all participated.

The Nashville Strong Babies also will participate in What to Expect: The Parenting Conversation with Meharry Medical College, Scarritt-Bennett and the New Life Center on Saturday, March 23. Participating parents will be exposed to new and useful skills in preparation of parenthood.

#### **Organizational Updates**

An MPHD contingent visited another possible site for a Woodbine replacement clinic last week. It is near the building we had been negotiating to buy in the Antioch area but is nearly twice as large and Metro already owns it. We remain ever hopeful.

If you plan to attend the fair and have three or more children who will be enrolling or receiving immunizations, please email the MNPS Early Learning Department for more information at EarlyLearningPreK@mnps.org.

Eligible children from birth through 18 years of age may receive free, federally-funded vaccine through the Vaccines for Children Program (VFC). Children from birth through 18 years of age must meet at least one of the following criteria are eligible to receive VFC vaccine: TennCare, Uninsured, American Indian or Alaska Native or Underinsured.

An administration fee of \$20 is charged for vaccines but will slide according to income. If you have private insurance, private stock vaccine is available. Money is collected at time of visit by cash, check, or credit card. Metro Health Department can bill CoverKids but we do not bill private insurance at this time. However, we will provide a patient services ledger if you wish to seek reimbursement. COVID vaccines will be available to individuals 6 months of age and older free of charge. If you have received previous COVID vaccines, please bring your vaccination card with you.
