The required fireresistance rating of exterior walls with a fire separation distance of less than or equal to 10 feet (3048 mm) shall be rated for exposure to fire from both sides.

Applicant Appeals: Applicant proposes to apply items 2, 3, and 4 of Section 703.3 of the 2018 IBC in determining the fire-resistance rating of the parking garage and residential apartment building exterior walls.
